ORDER

- 1. This order is issued in compliance with the directives of the Hon'ble Madras High Court in W.P. No. 16109 of 2024 and WMP No. 17639 of 2024, W.A. No. 2113 of 2024. It also addresses the ongoing connected matters in W.P. No. 23104 of 2024, W.P. No. 22444 of 2024 and W.M.P. No. 9846 of 2022 in W.P. No. 23712 of 2021 before the Madras High Court.
- 2. Whereas, Sri Nandhanam College of Engineering and Technology (hereinafter referred as "SNCET") (MTI No. 414046), located at Sri Nandhanam Maritime Academy, Nandhanam Nagar, Molagarampatti, Tirupattur, Tamil Nadu-635602, is a Maritime Training Institute (MTI) approved by the Directorate General of Shipping (hereinafter referred as "DGS") to conduct DGS-approved maritime courses. Whereas, SNCET is operated by the Sri Nandhanam Education and Social Welfare Trust, represented by Shri. PMN Mohan Krishnaa, Chairman and an interested party/petitioner in the aforementioned cases.
- 3. Whereas, the DGS issued an approval letter (F. No. 3-TR(2)/2006-GP Ratings/03) on 01.01.2018 to SNCET for conducting General Purpose Ratings (GP Rating) training course, allowing 40 candidates per batch, with one batch per year. This approval was valid until 30.06.2018, contingent upon constructing a swimming pool and obtaining approval for five STCW basic modular courses. Despite SNCET's failure to meet these conditions within the stipulated timeframe, a request for an extension was received on 04.04.2018. The DGS, by letter dated 16.05.2018 (F. No. 3-TR(2)/2006-GP-II/247), responded that the request for an extension would only be considered upon full compliance with stipulated conditions.
- **4.** Whereas, SNCET was initially granted approval (No.: TR/A/03/2019, File No. 3-TR (2)/2006-GP Rating-532) on 15.01.2019 for the "Pre-Sea Training GP Rating Course,"

valid for one batch of 40 candidates until 30.06.2019. Additional approval required compliance with specific criteria, including constructing a swimming pool and submitting an MoU for candidate placement. Following a reconsideration request and commitment to construct the pool, DGS issued conditional approval on 26.03.2020. Further a consolidated approval (No.: TR/A/09/2020, File No. 3-TR(2)/2006-GP-II) was granted on 18.05.2020 for 7 Pre-Sea Courses, including the GP Rating Course, valid for one year. This approval included conditions for compliance and inspections. However, due to the COVID-19 pandemic, again an extension of one year was granted on 18.05.2021, maintaining the same conditions.

- 5. Whereas, on 01.06.2022, DGS issued an amendment to the consolidated approval (No.: TR/A/02/2022, dated 10.05.2020) and the letter dated 18.05.2021. The amendment specified that the validity of approval is contingent upon the construction of a swimming pool within the approved premises by 31.05.2025, as per the undertaking dated 12.05.2022 submitted by MTI. However, as of this date, there has been persistent non-compliance with DGS orders, and the actions of SNCET and its representatives have amounted to contemptuous disobedience of these directives and flouting of opportunities afforded for rectification of deficiencies and to ensure continued compliance.
- 6. Noting that, despite being aware of the stipulated criteria for the approval and failing to meet these requirements, SNCET submitted several online applications. These applications were rejected by the DGS on multiple occasions due to continued and recurring non-compliance with infrastructure requirements, committed by SNCET.
- 7. Reiterating that the Directorate General of Shipping (DGS) has consistently sought compliance from the SNCET and has adhered to the orders of the Hon'ble High Court of Judicature at Madras in this regard. The DGS has repeatedly afforded opportunities to the SNCET by granting temporary approvals to ensure compliance with the mandatory criteria and standards mandated by DGS orders and circulars, aligning with global maritime standards as set forth by the International Maritime Organization (IMO) and the STCW Convention 1978, all in consideration of the welfare of innocent students.
- 8. Whereas, SNCET represented by the Sri Nandhanam Educational and Social Welfare Trust and its Chairman, PMN Mohan Krishnaa, have been persuading malicious attempts to harass and discredit official authorities, which also included levelling of baseless rumors against the diligent officials. Further, the Directorate has received numerous complaints from students and faculty of serious nature regarding inadequate infrastructure, non-



compliance with standards, misuse of faculty details without consent, holding and non-issuance of GP Rating Completion certificate, including threats.

- 9. Whereas, the ongoing non-compliance and representations submitted by SNCET and its Chairman, alongside the corresponding administrative actions, decisions, and deliberations undertaken by the Directorate General of Shipping (DGS), the Mercantile Marine Department (MMD), Chennai, and the STCW Compliance Board, has been meticulously documented and clarified in the latest DGS order pertaining to M/s. Sri Nandhanam College of Engineering and Technology, Tirupattur, issued under File No. 20-12/2020-TRG-DGS (Comp. No. 3732) dated 21.05.2024.
- 10. Whereas the above DGS order dated 21.05.2024, SNCET (MTI) submitted representations dated 25.05.2024 and 28.05.2024 against the DGS Order dated 21.05.2024. Subsequently the issue regarding GP Rating candidates of unauthorized batch (2021) of the MTI was placed and discussed in the 29th STCW Compliance Board meeting held on 24.05.2024 and the decision taken in the 29th STCW Compliance Board meeting was conveyed to all the candidates of the said batch vide DGS letter dated 29.05.2024.
- 11. Considering that, the DGS have received a letter bearing No. BES/Jul'24/DGS/360 dated 12.07.2024 from the Board of Examinations for Seafarers Trust, Navi Mumbai regarding issuance of Text books for July 24 batch of GP rating course-SNCET-MTI No. 414046 and requested to advice in the matter as to whether the institute is approved by the DGS for the ongoing 2nd batch of GP Rating course. Subsequently the said issue was again deliberated in the 34th STCW Compliance Board meeting held on 08.08.2024
- 12. Whereas, the Hon'ble High Court in *W.P. No. 16109 of 2024 and WMP No. 17639 of 2024* had rendered a judgment dated 21.06.2024, (received by MMD, Chennai on 04.07.2024) wherein it is laid down that:
 - "5. The Court believes that there is nothing untoward in this approach. Sinch both parties are agreed on the position that the processing of the application is currently ongoing, there is no need for intervention, except to fix the upper time limit within which such process will be completed. For this purpose, the parties agree that eight (8) weeks would suffice.
 - 6. Hence, application of the petitioner bearing No. 100592 dated 11.06.2023 will be processed in accordance with law and all applicable Rules and Regulations and a final view taken by the authority, either to accept or reject the same, the latter by way of a speaking order, within a period of eight (8) weeks from date of receipt of a copy of this



order. Needless to state, the principles of natural justice will be adhered to scrupulously as well."

- 13. Whereas, the MTI matter was again put before the STCW Compliance Board meeting held on 27.06.2024 for decision and deliberation. Further that, the SNCET has again made the various representations vide email dated 15.07.2024, 16.07.2024, 17.07.2024.
- 14. Noting that, subsequently, in compliance to the Hon'ble High Court of Madras Judgement Order dated 21.06.2024, On the direction of Directorate, MMD, Chennai had issued letter to SNCET on dated 24.07.2024 requesting to submit a comprehensive compliance report addressing all deficiencies, within seven (07) working days from the date of receipt of letter.
- 15. Considering that, midst of the ongoing administrative proceedings for verification of the claim of compliance by SNCET, the MTI field another WMP No. 9846 of 2022 in WP No. 23712 of 2021. The Hon'ble High Court of Madras has passed the judgement order on 18.06.2024 and mentioned the Para 3 of said judgement as below: "Considering the submission made by the learned counsel for the petitioner, this Petition is ordered and accordingly, the Writ Petition is restored".
- 16. Noting that, the SNCET vide email dated 02.08.2024 has forwarded Judgement Order dated 31.07.2024 passed by Hon'ble High Court of Judicature at Madras in W.A. No. 2113 of 2024 filed by Sri Nandhanam College of Engineering and Technology, Tirupattur. The Hon'ble High Court of Madras in its judgement had directed that "In the light of the rival submissions and considering the larger interest of the students, we direct the second respondent to consider the application of the appellant in the light of the additional documents furnished by them and process the same in accordance with law and all applicable Rules and Regulations and pass appropriate orders within two weeks, i.e., on or before 14.08.2024".
- 17. Whereas, in compliance to Hon'ble High Court of Madras Judgement order dated 21.06.2024 in *W.P. No. 16109 of 2024* and *WMP No. 17639 of 2024* and Judgement Order dated 31.07.2024 in *W.A. No. 2113 of 2024* passed by the Hon'ble High Court of Madras, the DG(S) has provided online hearing to the representative of MTI i.e. Shri PMN Mohan Krishnaa, Chairman before the 34th STCW Compliance Board meeting held on 08.08.2024. The same was informed to the MTI vide DGS email dated 02.08.2024.

- 18. Whereas, the Principal Officer, MMD, Chennai vide letter no. MMDC/PO/SAC/86-I/1617 dated 02.08.2024 has informed and recommended actions points to consider current issue of the SNCET (MTI).
- 19. Whereas, the SNCET issue regarding application bearing No. 100592 in the light of W.P. No. 16109 of 2024 and WMP NO. 17639 of 2024, W.A. No. 2113 of 2024. It also addresses the ongoing connected matters in W.P. No. 23104 of 2024, W.P. No. 22444 of 2024 and W.M.P. No. 9846 of 2022 in W.P. No. 23712 of 2021 before the Madras High Court, was again put up before the 34th STCW Compliance Board meeting held on 08.08.2024 for deliberation and decision. During the online hearing, all the submission made by Shri PMN Mohan Krishna, Chairman of SNCET vide emails dated 08.08.2024 were taken on record.
- 20. Noting that, to put on record that, the SNCET has voluntarily initiated the interactions on 29.07.2024 and also sent emails dt. 29.07.2024, and 30.07.2024 asserting that the chairman has appeared for personal enquiry and documentary audits at the MMD, Chennai. However, the MTI was not called for a personal enquiry or an audit by MMD, Chennai, rather was only provided with opportunity for submission of comprehensive documentary evidence of compliance. From the SNCET chairman's email communication and interactions, it could be inferred that his attempt was to fabricate evidence to mislead that a complete audit and verification process has occurred.
- 21. Whereas, SNCET during its personal hearing in 34th STCW Compliance Board meeting chairman Shri PMN Mohan Krishnaa has repeatedly referenced specific snippets from the Compliance Verification Report dated 11.12.2023, which suggested conditional approval based on compliance of deficiencies at Sr. Nos. 1, 7, 41, and 47. This selective representation is misleading and fails to provide a comprehensive picture of the regulatory expectations. However, it is pertinent to note that the Principal Officer, MMD, Chennai after having physically visited the MTI's premises during the subject inspections has recommended in the same report as:

"Recommended the Directorate to consider the proposal of the inspection team to allow the MTI for two batches of GP Rating in a year (40 students per batch) one batch in January and the other in July of each year for maintaining the continuity of the faculty. informatively, MMD, Chennai has recommended for two batches of GP Rating in a year (40 students per batch) one batch in January and other in July of each year vide letter No. MMDC/PO/SAC/85/8967 doted 12.12.2017 (copy enclosed).

Also, the existing running courses viz. Certificate Course in Maritime Catering (CCMC), Bosic Safety Training (BST) and Security Training for Seafarers with Designated Security

Duties (STSDSD) may continue to be allowed with present approved intake capacity and batch frequency.

Enhancement of batches of existing running courses and any new course may be considered only after satisfactory CIP inspection in the year 2024 and a course-specific inspection."

It may duly be noted that the above-referred recommendation was made by the inspection team and the PO, MMD, Chennai prior to the knowledge of the receipt of the complaints of the 19 students and subsequent discovery of information that the MTI conducted unauthorized batches of G.P. rating Courses during the year 2021, 2022 and 2023.

- 22. Whereas, after due scrutiny of all the documents submitted by the MTI; in compliance with judgments of Hon'ble Madras High Court in WP 16109 of 2024 and WMP No. 17639 of 2024, dated 21.06.2024 and WA 2113 of 2024, dated 31.07.2024 and accordingly in compliance with directives of DGS, it is noted that deficiencies at Sr. No. 1, 39 and 41 stand not rectified and rest of the deficiencies need to be further ascertained by means of compliance verification inspection.
- 23. Noting that, despite claims of compliance, upon verification it was found that the CAS attendance system at the MTI remains non-operational, as admitted by SNCET in their submissions dated 29.07.2024. The present Principal of the MTI Capt. Ramesh Babu Ramakrishnan (INDOS: 00N17548), who claimed to have enrolled for the AECS course commencing on 27.05.2024, has not undergone the training as verified through the DGS E-governance system.
- 24. Whereas, SNCET failed to demonstrate proof of compliance with the DGS Order dated 21.05.2024 in areas including (i) Undergoing compliance verification inspection, (ii) an Explanation regarding the conduct of unauthorized batches as against approval of a single batch per year since 2021 to 2023 (iii) MTI's firm commitment regarding the construction of the swimming pool in compliance with DGS training Branch Circular No. 07 of 2018 (iv) Written undertaking from the MTI management to adhere to the DGS Circulars and rules without demonstrating non-cooperation.
- 25. Noting that although the SNCET has only been inspected by the MMD, Chennai in 2023; your MTI has not undergone CIP inspection after 2018. MTI has not undergone CIP inspection in 2024 and it is further noted that the MTI has failed to comply with DGS Training Branch Circular No. 31 of 2018 for placement of 85% of trainees onboard ship within 12 months of completion of the course and not in compliance with DGS Order 04

of 2016 viz. para 13 (graded A1 for two consecutive years) & para 17 of CIP inspection of Pre-sea Maritime Training Institute (scored 80% or above in Section V - Placement Records for the last two years).

26. The deficiencies identified and threshold of compliance and non-compliances still continued to be committed by you / MTI is as provided hereunder:

From the above, it is evident that SNCET (MTI) has not provided substantive compliance with the deficiencies identified during inspections. The MTI has attempted to misrepresent the status of its compliance efforts through selective and misleading use of internal recommendations. Despite multiple opportunities and clear directives from the DGS, the MTI has failed to demonstrate compliance with the DGS Orders and to provide necessary documentation to substantiate their claims. It is noted that the deficiencies identified and remaining rectified fall within the ambit of major deficiencies.

Having found that, the persistent non-compliance obstructing DGS efforts to establish a Quality Standards System to ensure compliance with mandatory rules and regulations, as mandated by the STCW Convention through DGS orders and Circulars and fulfil its international obligations, potentially affecting the employment prospects of the students and Indian seafarers on both domestic and foreign vessels. It is important to note that, Hon'ble Madras High court through its various precedent such as in *WP No. 1639 & 1651 of 2019* judgement dated 09.09.2019 has re-affirmed the absolute authority of the DGS in all matters concerning maritime training.

27. It is pertinent to note that the Hon'ble High Court of Madras with regards to the conduct of unauthorize G.P. Rating batches in WP 6988 of 2020 as dated 06.08.2020 have observed that, the DGS cannot be directly held responsible for the issues arising from the unapproved GP Rating course and in the wrongdoing regarding the collection of fees or the lack of course approval on the part of MTI. The court emphasized that fulfilling conditions, such as constructing a swimming pool, does not equate to automatic approval; formal inspection and written approval are required. It was highlighted that certificates issued under Section 78 of the Merchant Shipping Act, 1958, must be for courses conducted with proper approval. This is crucial to ensure the maintenance of quality in maritime education, as these certificates have significant international implications under the STCW Convention

1978. The students who undergo this training become seafarers, employed not only on Indian ships but also on foreign vessels, making it imperative that these certificates be issued with utmost responsibility. The statutory backing under the Merchant Shipping Act, 1958, and the rules framed thereunder reaffirm the importance of compliance.

Therefore, in light of the prevailing circumstances and after a thorough examination of the representations submitted by SNCET and its Chairman, and in alignment with the deliberations of the STCW Compliance Board held between 25.04.2024 to 08.08.2024, as well as the Hon'ble Madras High court orders in W.P. No. 16109 of 2024 and WMP No. 17639 of 2024, W.A. No. 2113 of 2024. It also addresses the ongoing connected matters in W.P. No. 23104 of 2024, W. P. No. 22444 of 2024 and W.M.P. No. 9846 of 2022 in W.P. No. 23712 of 2021 before the Madras High Court, the Directorate General of Shipping hereby orders that:

- (i) The application No. 100592 of 2023 submitted by the MTI for enhanced intake in the G.P. Rating batch is hereby rejected.
- (ii) The second G.P. Rating batch from July to December being conducted at Sri Nandhanam College of Engineering and Technology (MTI) considered to be unauthorized and hereby directed to immediately withdraw the batch and refund fees to the candidates.
- (ii) Approval for the second batch of the G.P. Rating Course will only be considered afresh upon proof of strict compliance with the DGS orders and circulars, that has to be substantiated by submission of documents and then by compliance verification inspection. Approval shall be subject to mandatory CIP inspection and the satisfactory verification of the submitted compliances.
