Dated: 10.02.2016

- WHEREAS the Directorate General of Shipping has authorized the Facilitation Centres (FCs) of INSA, MASSA, FOSMA, ICCSA, CMMI and IMEI to issue the Certificate of Proficiency as applicable to ratings / trainees / petty officers vide NT/ENG Circular No. 12 of 2012 dated 28.12.2012 and addendum to the said circular dated 16.04.2013.
- WHEREAS the Directorate General of Shipping has Issued NT/ENG Circular No. 3 of 2015 dated 18/11/2015 authorizing the above mentioned Facilitation Centres also to issue Certificate of Proficiency as Able Seafarer Deck and Able Seafarer Engine.
- NOTING that the Directorate General of Shipping has also prescribed the format of Certificate of Proficiency to be issued to ratings and able seafarers in the aforesaid circulars for reference by the authorized facilitation centres for preparation of the Certificate of Proficiency and that such format requires entering of Candidates Passport No.
- NOTING ALSO that the Passport No. of Candidates does not remain same as each time the Passport is renewed or reissued by Passport authority a new number is issued.
- 5. NOTING FURTHER that the Directorate had subsequently issued communication to Facilitation Centers authorizing them to use their logo and address at the top of the certificate which is recently being observed to be not in line with the aforesaid circulars. The stated deviation from the requirement of the circulars have also been brought to the notice of the Directorate by other Administration.
- BEING CONCERNED that in some part of Africa especially west Africa it has been represented by the stakeholder that the inspectors of these countries raise objection incase they notice any variance in the Passport number mentioned in the Seafarers Certificate of Proficiency with that of the Passport including any other deviation in the format of the certificate that have been prescribed.
- HAVING CONSIDERED that this is an inconvenience to the Seafarers, it has been decided by the Competent Authority that hence forth the Certificate of Proficiency are to be issued to the Seafarers without the Passport No. and logo of the Facilitation Centers as per the prescribed sample format attached to this circular. Nevertheless a self authorised copy of the passport to be collected from the Candidates by the facilitation centers and retained with the candidates application for the purpose of the record and verification.
