- It is further informed that the Board of Trustees, Seamen's Provident Fund have 4. expressed their serious concern over the non-payment of pf contributions.
- Hence, it is appeal to the victim seamen/seafarers, who had performed voyages on 5. the above defaulter's companies vessels, and their provident fund contributions are not deposited in SPFO to approach this office alongwith the documentary evidence i.e. copy of CDC book, Portage Bill, Account of wages, copy of Article of Agreement etc. So that this office may ascertain their liability & may recover their provident fund contributions as per the Provision of the Seamen's Provident Fund Act & Scheme, 1966.
