Subject: Addendum to M.S.Notice 19 a of 2011 – Revised requirements
Of International Ship and Port Facility Security Code –
Implementation on Indian vessels.

1. This Directorate has, vide M.S.Notice 19 a of 2011 stipulated requirements of implementation of ISPS code of various types/sizes of Indian vessels.
2. The subject has been re-examined in respect of non-propelled MODUs and considering that non-propelled MODUs would, in their normal operations, not interface with international shipping, it is clarified that ISPS requirements on such vessels would not be applicable.
3. Accordingly, a revised matrix of ISPS requirements, deleting the reference to non-propelled MODU is enclosed for future reference.

This is issued with the approval of Nautical Advisor to the Govt. of India.

3. A separate Ship Security Certificate for RSV is not necessary as this would be included in the harmonized Certificate for RSV.
4. ** Vessels ≤ 300 GT may fit/install AIS Type A or B.
