Sir,

I am directed to refer to subject matter and to state that it has been realized that in the DG Shipping Order No. 19 of 2013 (dated 16.09.2013), only the National Institute of Oceanography (NIO) had been prescribed to carry out of wave height data analysis on coast of India. In order to facilitate more service providers, a decision has been taken to include more Govt of India agencies having expertise to carry out such study, in addition to earlier prescribed NIO.

As such, I am directed to enclose herewith an addendum vide reference of even no., dated 28.10.2014.

Therefore, after adding necessary text as per enclosed addendum, the revised para 4 shall read as follows-

Quote -

"In accordance with the provisions under Section 2 and Section 3 (41) of the M.S. Act, partially smooth water will be an area having a significant wave height of 2 meters. The coastal states seeking extension of Inland water beyond the base line may carry out relevant analysis through the National Institute of Oceanography (NIO), Indian National Centre for Ocean Information Services (INCOIS) or any other Govt of India organization competent to carry out such study".
