(Corrigendum to the M.S. Notice No.7, 11&15 of 2013)

Subject: :-Implementation of the Maritime Labour Convention, 2006-voluntary inspection of Indian flag Ships-reg.

A 'Voluntary Inspection' of Indian flag ships for MLC, 2006 compliance was facilitated and detailed guidelines for such inspections and issuance of 'Statement of Compliance' (SOC) for MLC (2006) were issued vide M.S. Notice No.7 of 2013 [F.No.16(5)/CR/2010] dated 01.02.13 M.S. Notice No.11 of 2013 [F.No.16(5)/CR/2010-Vol-I] dated 16.04.13 and M.S. Notice No.15 of 2013 [F.No.16(5)/CR/2010-Vol-I] dated 31.05.2013.

- 2. Minor bottlenecks, discrepancies are being experienced / noticed in the process of the above 'Voluntary Inspection' procedures. The following additional guidelines are therefore issued to be followed during the course of the said inspection/ issuance of statement of compliance from the application, processing & issuing stages.
- 2.1. The Shipping companies/ manning agents shall ensure that all details in the Article of Agreement are duly completed as per the guidelines issued in DG Shipping Order No. 04 of 2013 [F.No. CR/CDC/02/2013-AOA] dated 01.03.2013 and submitted to the Shipping Master concerned.
- 2.2 The name and address of the Manager for the stated vessel, holding "Document & Compliance" will be verified by the Registrars and reflected in DMLC Part-II.

- 2.3. As the actual Date of Registry of the ship is required to be entered in the Statement of Compliance, the Registrar's shall verify the date of registry from the Certificate of Registry records and intimate the same to the R.O. To bring uniformity, such date shall be the date when the vessel entered Indian registrar at the initial stage.
- 2.4. The registrars may sign all pages of DMLC Part-II after verification including the forwarding note on last page as indicated in M.S. Notice No., 15of 2013 [16(5)/CR/2010-Vol-I] dated 31.05.2013 and forward the original to ship owner manager, which will be kept on board with a copy to the Indian Register of Shipping (IRS).
- 2.5. The IRS shall forward a statement of Statement of Compliance (SOCs) issued on a biweekly basis along with copies of such SOCs electronically to the registrars and DG Shipping
 - All other terms & conditions/guidelines stipulated in M.S. Notice 07,11 & 15 of 2013 remains uncharged mutate- mutandis.
 - 4. These issues with the approval of the Director General of Shipping & ex-officio Additional Secretary to the Government of India.
