Sub: Application for a new Continuous Discharge Certificate (CDC)-cum-Seafarers Identity Document (SID) (other than to the candidates who have undergone DGS approved pre-sea training courses)-reg.

The application for new Continuous Discharge Certificate (CDC) in the individual categories (other than to the candidates who have undergone DGS approved pre-sea training courses) have been made online and the Shipping Master's Government Shipping Offices have been directed to process and issue such CDC by following the procedures prescribed in the DG Shipping Order No. 20 of 2013[F. No. 3(2) CR-2006] dated 30.10.13. Consequent, to the above said order, the procedure of submission of only an offline application for such categories, as prescribed in M.S. Notice 24 of 2012 [F. No.3(8)CR-2006] dated 04.12.12 is dispensed with, from the date of issuance of this M.S. Notice. The Shipping Masters, Govt. Shipping Offices shall not accept and process any application which are sent only offline for the issue of new CDC in individual category, henceforth.
