
Sir,

Delegation of financial and administrative powers to the Director General of Shipping, Mumbai-reg.

Sir,

I am directed to refer to DGS's letter no. PB-30(1)/2015-Misc dated 01.04.2015 and to say that in supersession of the powers delegated to DGS vide this Ministry's letter no. SW/I-MDS(18)/82-MA dated 30.06.1983 except in respect of things done or omitted to be done before such supersession, the President is pleased to delegate certain financial and administrative powers to the Director General of Shipping, Mumbai for greater functional autonomy and accountability. The statement of delegation of financial and administrative powers to the Director General of Shipping, Mumbai is enclosed at annexure. The exercise of these enhanced powers will be subject to the following conditions:-

- (i) cases involving exercise of powers beyond those of a Head of Department would be referred to the DDG(Finance) for his concurrence.
- (ii) cases required to be referred to the Financial Adviser in the Ministry will be referred to him for his advice/concurrence directly by the DDG(Finance) without routing them through the Ministry.
- (iii) while issuing sanction in exercise of the enhanced powers, it would be specifically mentioned in the sanction letter that the same has been issued in consultation with the DDG(Finance) or the Financial Adviser in the Ministry as the case may be.
- (iv) Guidelines, conditions, etc. laid down in GFRs, DFPRs, etc. for exercise of certain powers will be strictly adhered to while exercising these powers.
- 2. This issues with the concurrence of IFW of this Ministry vide their dy. No. 221/TF-1/15 dated 11.06.2015.
