Ministry of Shipping Gol, New Delhi has constituted shadow Committees to deliberate response of the country to be presented before various Sub-Committee Council and Assembly meetings of the IMO with a view to strengthen India's engagement in the IMO. The agenda for the IMO Meetings would be discussed in details with all the stakeholders in the office of the DG(Shipping) and the same would be placed before the Shadow Committee to get clarity on agenda items and also for deciding the course of action and stand to be taken by the delegation in the IMO.

- 2. In view of the above it is felt that, here is a need to have a proper system in the office of Director General of Shipping Gol, Mumbai, so that the preparation on relevant issues is done in advance—that would enable—the Indian delegation to have a meaningful participation in the various IMO Meetings.
  - Under the circumstance the following mechanism decided by the competent authority :-
    - (a) The Joint DG(S), Nautical Advisor & Chief Surveyor stand nominated for representing the DGS in the shadow committees of the Ministry of Shipping GoI, New Delhi. They shall be primarily and singularly responsible for shepherding and ensuring proactive and ensuring proactive and coordinated response from the DGS for their respective areas;
    - (b) The Co-ordination work all International Maritime Organization (IMO) meetings & other International Conferences shall be done by DDG(International Co-operation). He will ensure the following:-
      - (i) Will Co-ordinate with all branch heads of DGS to ensure that preparatory meeting for all shadow committees other International Conferences and Meetings are conducted and draft response of India is formalized.

- (ii) Will maintain a repository of debriefing report after each meeting or conference and Co-ordinate follow up action by respective divisions of DG. Shipping.
- (iii) Will coordinate submission of papers for the next IMO session, and other international conferences &
- (iv) will Co-ordinate with senior officers for nominations of DGS representatives for international conferences and meetings.
- (c) The respective Technical Branches of DGS will assure that the shadow committee representative based at Mumbai are fully prepared and their draft reference are in line with the view of the maritime administration of the country.
- (d) DDG(Coordination) will be designated as DDG (Coordination and International Cooperation)
