## SD Circular No. 1/2014

Sub: Monthly statement on the purchase and sale of Indian flag merchant ships-reg.

The Directorate General of Commercial Intelligence & Statistics (DGCI&S), Kolkata, under the Department of Commerce, Govt. of India, is the accredited official organization for the collection, compilation and dissemination of India's trade [export- import : EXIM] statistics and allied commercial information.

Such statistics and information are structured under the ITC head, by the DGCI&S, for various merchandise products, including for sea-borne trade/ merchant ships. The DGCI&S requires, in this context, data on prices of the purchase and sale transactions of Indian flag merchant ships, in the prescribed proforma, in order to publish various trade related data oriented information, for the benefit of various stakeholders, and Govt. agencies. Thus, such a compilation and publication by the DGCI&S is important and useful. A copy of the said proforma prescribed, for the purpose, by the DGCI&S is enclosed for reference [Annexure-I: 1 pagel.

Accordingly, all the Indian flag shipping companies are hereby advised to send the 3. above mentioned data relating to the sale & purchase transactions in respect of their vessels, in the said proforma, directly to the DGCI&S, Kolkata, on a monthly basis, under an

intimation to this office, by the 10<sup>th</sup> of every following month.
