## No. 26(1) CR/2003-II

- Sub :- Payment of levy fee on the basis of the Articles of Agreement signed by Indian Shipping Companies- enhancement of the said fee-reg.
- 1. The seamens' levy fee paid by the owners and agents of Indian shipping companies for an engagement by them of seamen on the basis of the Articles of Agreement entered enhanced from 250/- (Rupees two hundred and fifty only) to 500/- (Rupees five hundred only) for every seamen so engaged in terms of the Ministry of Shipping, Govt. of India Gazette Notification No. GSR 654 (E) (Letter No. ST-17011/2/2011-MA) dated 30.08.11 in terms of the Merchant Shipping (Levy of Seamen's Welfare Fee) Amendment Rules, 2011.
- 2. The said upward revision has come into force with effect from 30.08.11 official gazette, i.e. the said gazette notification on date.
- 3. Owners / agents of Indian Shipping companies are hereby consequently advised to abide by the said Government Gazette Notification in the matter.

नई दिल्ली, 30 अगस्त, 2011

सा.का.नि. 654(अ). वाणिज्य पोत परिवहन अधिनियम, 1958 (1958 का 44) की धारा 218 की उप-धारा (2) और धारा 457 का खण्ड (डी) और (ई) द्वारा प्रदेश शक्तियों का प्रयोग करते हुए, केन्द्रीय सरकार एतद्वारा वाणिज्य पोत परिवहन (नाविक कल्याण शुल्क उद्ग्रहण) नियम, 1974 के आगे के संशोधन के लिए निम्नलिखित नियमों को बनाती है, अर्थात् :-

- (1) यह नियम वाणिज्य पोत परिवहन (नाविक कल्याण शुल्क उद्ग्रहण) संशोधन नियम, 2011 कहलाया जाएगा।
- (2) यह आधिकारिक राजपत्र में उसकी प्रकाशन की तारीख से प्रवत्त किया जाएगा।
- 2. वाणिज्य पोत परिवहन (नाविक कल्याण शुल्क उद्ग्रहण) नियम, 1974 का नियम 3 में, उप-नियम (1) में, ''दो सौ पचास रुपए'' शब्द के लिए ''पाँच सौ रुपए'', का शब्द प्रतिस्थापित किया जाएगा।

# MINISTRY OF SHIPPING NOTIFICATION

New Delhi, the 30th August, 2011

G.S.R. 654(E).—In exercise of the powers conferred by clauses (d) and (e) of sub-section (2) of Section 218 and Section 457 of the Merchant Shipping Act, 1958 (44 of 1958), the Central Government hereby makes the following rules further to amend the Merchant Shipping (Levy of Seamen's Welfare Fee) Rules, 1974, namely:—

- These rules may be called the Merchant Shipping (Levy of Seamen's Welfare Fee) Amendment Rules, 2011.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In rule 3 of the Merchant Shipping (Levy of Seamen's Welfare Fee) Rules, 1974, in sub-rule (1), for the words "two hundred fifty rupees", the words, "five hundred rupees" shall be substituted.
