Sub: Issuance of Indian CDC to hospitality crew working on cruise vessels and also to seafarers who are working on board trading vessels without an Indian CDC - reg.

The DG Shipping Order No. 8 of 2013 [F. No. CR/CDC (Special)/ 2013] dated 22.03.13, has enable an for issuance of Continuous Discharge Certificate-cum-Seafarer's Identity Document (CDCs) for additional categories of Indian seafarers, such as hospitality crew currently working on cruise vessels & merchant vessels without any Indian CDC.

The following corrigenda is now effected in the said DG Shipping Order No. 8 of 2013, mutatis - mutandis.

Similarly, the other ranks for which a COC is required is also not covered in this Order. As the same is already provisioned for the Merchant Shipping [CDC] Rules, 2001
