## DG Shipping Order No. 06 of 2014

(Corrigendum to the DG Shipping Order Nos. 8 of 2013 and 09 of 2013)

Sub: Issuance of Indian CDCs to hospitality crew working on cruise vessels and also to seafarers who are working on board trading vessels without an Indian CDC - reg.

The Director General Shipping Order No. 8 of 2013[F.No. CR/CDC (Special)/ 2013] dated 22.03.13, has enabled an issuance of Continuous Discharge Certificates-cum-Seafarer's Identity Documents (CDCs) for additional categories of Indian seafarers, such as hospitality crew currently working on cruise vessels without any Indian CDCs.
