The Merchant Shipping [M.S] Notice No. 10 of 2014 [F.No. 27(1)/CR/2001-Pt-II] dated 15.07.2014 was issued by this office on the aforesaid subject.


2. In partial modification of the said M.S Notice No. 10, of 2014, the following provisions are introduced therein to with an immediate effect;

1	2.3	As per the prevalent procedures applications for the purpose are received by post and CDCs are also issued to such persons by post only. The latter must be done only by speed post A/D (acknowledgement due) for due record. The details of the new/replaced CDCs are recorded in the official CDC register(s) concerned at the CDC issuing Government Shipping Office.	CDC s shall be issued only by speed post A/D, except in rare/exceptional circumstances, as may be considered/determined by the Shipping Master concerned & recorded by him in writing, cogently.

3. All the other terms and conditions of the connected M.S. Notices No. 23 of 2003, 9 of 2004, 14 of 2005, 17 of 2008, 2 of 2011 & 10 of 2014 on the subject, remain unchanged.

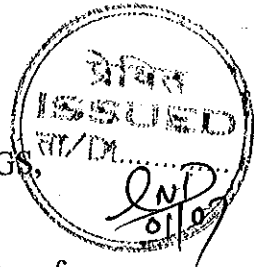
