K. Marg, Mumbai- 400 001, along with. (1) Forwarding letter on the official letter head of the authorized dealer. (2) Supporting documents of previous purchase order in the related field. (3) Supporting technical literature/brochure of the brand item for which the rate is quoted.
2	Loss or delay in postal/courier transit will not be considered as valid reason for non-receipt of the tender in time.
3	Quotations are invited from the authorized dealer (attach certificate/letter) only in sealed envelopes super scribing the wordings " <u>Quotation for Supply of 1.5 ton Inverter split Air Conditioner</u> ". Quotation should be submitted by 26/06/2023 before 04.30 p.m.

6	All damaged or unapproved goods shall be returned at the risk and cost of the bidder and the incidental expenditure thereupon shall be recovered from the concerned party.
7	Tender should also confirm the stipulated warranty period mentioned with the specification of item at the columns specified in the price bid Proforma.

14	Liquidated Damage: In case the supply is not completed within the aforesaid stipulated period liquidated damaged @0.1%of the total value of order for delay of per day or part there of subject to deduction of maximum 10% of the value of order.
