Subject: Implementation of E-Procurement Threshold.

In pursuance of Rule 160 of the General Financial Rules (GFR) 2017, it is hereby notified that the Directorate General of Shipping (DGS) mandates the adoption of eprocurement portals for all procurements. The following instructions are issued for strict compliance:

1. Mandatory Use of E-Procurement Portals:

All wings and branches of the DGS are required to receive and process bids exclusively through e-procurement portals for all procurements of goods, services, and works.

2. E-Procurement Threshold:

The e-procurement threshold for the Directorate General of Shipping is hereby established at Rupees One Lakh. Accordingly:

- All procurements with an estimated value exceeding Rupees One Lakh shall be processed exclusively through e-procurement portals.
- Procurements below the threshold may continue to follow existing manual or alternate processes, as applicable.

3. Roles and Responsibilities assigned:
