OFFICE ORDER NO. 81 of 2025

The Ministry of Ports, Shipping and Waterways, GoI has delegated financial and Administrative powers to the Director General of Shipping vide letter No. A-11019/2/2012-MA dated 13.07.2015 wherein the following powers are vested with the Director General of Shipping:

- (i) **In Point No. 16** empowers the Director General of Shipping (DGS) to exercise full powers for the fixation of pay under FR 27 in respect of posts for which Director General of Shipping is the Appointing Authority.
- (ii) **In Point No. 14** states that the Director General of Shipping is the Appointing Authority for Group 'A' posts (upto Director level) under its jurisdiction.

2. In accordance with the delegated powers, the Director General of Shipping exercised these delegated powers, as per Gazette Notification No. G.S.R. 569(E) dated 30.09.1997 issued by the Department of Expenditure, Ministry of Finance. Consequently, the pay scale of the post of Executive Officer was revised vide Office Order No. 95/2017 dated 29.09.2017 (copy enclosed), based on the Ministry's written advice on DGS letter dated 09.05.2018 stating that "*The matter concern within the delegated power of DGS*".

3. However, due to various public grievances, the matter was re-examined and the Office Order No. 95/2017 dated 29/09/2017 was withdrawn, vide Office Order No. 58/2022 dated 28.09.2022. (copy enclosed)

4. This matter was again referred to the Ministry of Ports, Shipping & Waterways, GoI, vide DGS letter No. 22-52/2/2021-PER-DGS (C. No. 9841) dated 15.04.2025, the Ministry reiterated its earlier position vide letter No. ST-16011/18/2022-MA (355923) dated 21.05.2025 that the Director General of Shipping has full powers for fixation of Pay under FR-27 in respect of the posts for which the Director General of Shipping is the Appointing Authority. Accordingly, the Ministry advised that the Director General of Shipping may take necessary action for revise the pay scale in accordance with 5th CPC recommendations.

5. In light of the above, the pay scale of the post of Executive Officer, as approved by the Director General of Shipping and notified vide Office Order No. 95/2017 dated 29.09.2017, is hereby restored and shall remain valid with effect from its original date of issue. Consequently, the Competent Authority is hereby sets aside the Office Order No. 58/2022 dated 28.09.2022. (copy enclosed)



OFFICE ORDER No. 95 / 2017

As per the Central Civil Service [Revised Pay] Rules, 1997, vide Govt. of India Notification No. 50[I]IC/97 dated 30.09.1997 [in pursuance of recommendation & acceptance of the 5th CPC] and in terms of its Para 46.13 at its First Schedule, Part-B, the Pay Scale to the post of Administrative Officer [common nomenclature to cover different nomenclatures in different organizations carrying identical pay scales which includes the post of Executive Officers of the Directorate General of Shipping] was Rs. 7500-250-12000. However, the scale of pay to the post of Executive Officers of the Directorate General of Shipping was inadvertently fixed Rs. 7450-225-11500, which was not as per the above terms of CCS [RP] Rule, 1997 at Para 46.13 at its First Schedule, Part-B. The Director General of Shipping and Special Secretary to the Govt. of India, being competent authority, has decided to correct the fixation of the scale of pay to the post of Executive Officers of the Directorate General of Shipping as per the CCS [Revised Pay] Rules, 1997 w.e.f. 01.01.1996, as follows:


OFFICE ORDER NO. 58/2022

The matter regarding upgradation of the pay scale of the post of "Executive Officer" from the scale of Rs.7450-11500 to the scale of Rs.7500-12000/- [as per 5th Pay commission] has been re-examined after receipt of various Public Grievances on the CPGRAM Portal.

After detailed examination it has been observed that such revision/upgradation can be granted only after notification of Recruitment Rules and as per provisions of the GFR, the revised/upgraded scales are required to be implemented prospectively and in consultation with the Ministry of Finance. However, in the instant case the pay scale has been revised/upgraded without amending the RRs and the arrears have been drawn from retrospective effect without approval from the Ministry of Finance.

In view of the above, the Competent Authority has withdrawn the Office Order No. 95/2017 dated 29.09.2017 with immediate effect and directed to re-fix the pay scale upgraded based on the said Office Order. The excess amount subsequently drawn based on said upgradation should be recovered.

This issues with the approval of the Director General of Shipping and Additional Secretary to the Government of India.
