Workshop on India's IMO Engagement Highlights Call

for Stronger Global Presence

The Directorate General of Shipping in collaboration with Indian Register of Shipping (IRS) and The Institute of Marine Engineers (India) [IMEI] organized a one-day workshop in Mumbai on India's engagement with the International Maritime Organization (IMO). The event brought together senior government officials, regulators, industry leaders, classification societies, and maritime professionals to deliberate on strengthening India's role in global maritime governance.



The programme opened with registration and a traditional lamplighting ceremony, followed by a welcome address from Shri David Birwadkar, Chairman of IMEI Mumbai, who set the objectives of the workshop. He emphasized that India, with its maritime heritage and growing economic influence, must move beyond being a passive observer at IMO to becoming a purposeful, proactive, and powerful participant shaping global maritime regulation. He also conducted the entire proceedings with aplomb as the Emcee for the workshop.



The Chief Guest, Shri Arun Sharma, Executive Chairman of the Indian Register of Shipping (IRS), described the IMO as the cornerstone of maritime governance. Stressing India's strategic position as a maritime nation with a vast coastline, large fleet, and growing seafarer base, he urged for stronger engagement at IMO. He noted that shipping

is entering a new "super-cycle" with major transitions in energy, digitalization, and sustainability, and that India must be proactive in shaping regulations. He also highlighted the potential of nuclear energy in shipping, with the Nuclear Energy Maritime Organization (NEMO) gaining NGO consultative status at IMO. Shri Sharma recalled IRS's leadership in the International Association of Classification Societies (IACS) in 2019–20, stressing the importance of building alliances and fostering trust to influence global governance.

Guest of Honour, **Shri Shyam Jagannathan**, IAS, Director General of Maritime Administration (DGMA), presented the Indian Growth Story, underlining India's demographic dividend, democratic resilience, and dynamism as drivers of its rise as a Contd. on page 4

Informatively, SCI has already inducted VLGC "SAHYADRI" on 14th August, 2025, which has already been deployed in the trade. This marks the successful completion of the acquisition of two second-hand VLGCs, each with a capacity of 82,000 CBM, under the MoA signed on 04 July 2025. Further with recent acquisition of above two VLGC, SCI has now total of 3 VLGC in its diversified fleet.

This newly acquired vessel bearing IMO number 9356892, built in South Korea, is renamed as after the Shivalik mountain range of the Himalayas. This vessel further strengthen SCI's and country's LPG transportation capacity, enhancing secure and efficient movement of vital energy supplies between the Persian Gulf and India.

VLGC 'Shivalik' has a cargo carrying capacity of 82,000 CBM, with 225 meters length overall (LOA), 36 meters in width, and depth of 22 meters. It is classed with both DNV and Indian Register of Shipping (IRS), ensuring strict compliance with the established international standards and regulations thereby enhancing maritime safety, environmental protection, reducing risks and improving efficiency.

With this induction, SCI's fleet now stands at 58 owned vessels totalling 5.26 million DWT, covering various categories, including Crude Oil Carriers, Product Tankers, Bulk Carriers, Cellular Container Vessels, LPG, and Offshore Vessels.

Aligned with the Government of India's Maritime Amrit Kaal Vision 2047 and Maritime India Vision 2030, SCI's expanded LPG fleet underscores its commitment to promoting Atmanirbharta in shipping, boosting India's energy security, and enhancing its global competitiveness in the maritime sector.

Chairman SMPK Inaugurates **Road Train System and Safety**

In a major step towards modernizing operations and strengthening safety protocols, Sri Rathendra Raman, Chairman of Syama Prasad Mookerjee Port, Kolkata (SMPK), inaugurated two significant initiatives at the Haldia Dock Complex (HDC) the Road Train System and the Safety Man Cage at the Haldia International Container Terminal Pvt. Ltd. (HICT).

The initiatives are part of SMPK's ongoing efforts to enhance operational efficiency, improve workplace safety, and promote sustainable logistics, reinforcing HDC's status as an advanced hub for modern container handling.

The highlight of the launch was the Road Train System, introduced at HDC for the first time. This innovative system is designed to revolutionize the internal movement of empty containers within the terminal. Using a single high-powered truck (horse) to pull multiple trailers, it enables the simultaneous transfer of several containers between the quay and storage yards, thereby boosting vessel productivity and reducing turnaround times. The system's benefits extend to cost efficiency, as it reduces the number of trucks and drivers required; operational efficiency, with the capacity to carry up to four 20-foot or two 40-foot containers per trip; and environmental sustainability, by lowering truck movements and associated emissions.

maritime superpower. He shared that the Blue Economy currently contributes 4% to GDP, a figure expected to grow significantly under Maritime India Vision 2030 and Maritime Amritkaal Vision 2047. Key goals include increasing India's share of the global seafaring workforce from 12% to 20% and rising to become the world's fifth-largest shipbuilding

nation. He emphasized IMO's role in consensus building and standardization, urging India to take leadership through policies, partnerships, and progress.

partnerships, and progress.

Shri Rajeev Nayyer, President of IME(I), stressed the importance of evidence-based, data-backed inputs at IMO.

Shri Praveen Kumar Mishra, Managing Director of IRS, recalled India's long-standing contributions at IMO since 1959, highlighting IRS's contribution vide technical papers and leadership in initiatives such as Green Voyage. He strongly advocated for a permanent Indian representation at IMO to ensure continuity and stronger networking with likeminded nations.



Shri Sushil Mansing Khopde, Additional DGMA, also pressed for permanent representation, emphasizing the alignment of industry and national interests. He called for showcasing Indian initiatives such as Sagar Mein Samman and Sagar Mein Yogon international platforms.

Capt. S.I. Abul Kalam Azad,
Nautical Adviser-cum-DGMA,
recommended the placement of
technical domain representatives,
supported by Senior and Junior
Professional Officers, to enhance
continuity at IMO. He highlighted
India's potential to groom future



leaders for key IMO positions, even aiming for the Secretary-General role in the long term. He encouraged collaboration through shadow committees and stronger engagement of professional bodies like the Company of Master Mariners of India (CMMI) and Institute of Naval Architects (INA). He also stressed the need to develop ancillary shipbuilding equipment indigenously to strengthen India's shipbuilding sector.



Adding a technical perspective, Shri Aniruddha Chaki, Deputy Chief Surveyor at DGMA, presented on IMO processes and India's participation under the NAVIC Cell 24. He remarked, "India must move from mere participation to meaningful influence at the IMO. By leveraging NAVIC's structured approach, we can ensure

continuity in our contributions and bring India's maritime priorities to the center stage of global discussions."

The technical sessions that followed deepened discussions on IMO committees.. The first session, moderated by Shri Rajeev Nayyer, delved into the workings of the Marine Environment Protection Committee (MEPC) and its subcommittees, with a focus on environmental sustainability. Contributing to the discussion were Shri Kunal Sharma and Shri N. Girish from the Indian Register of Shipping; Shri Senthil Kumar Jayaraman PO; Shri I.N Bose representing INSA; along with Shri Mahesh Subramanian and Shri B. Venkat from AESM; who all brought valuable insights to the session.



The second session, led by Shri Sunil Kumar of GESCO, addressed safety challenges through the Maritime Safety Committee (MSC). This saw the participation of Capt. S.I. Abdul Kalam Azad along with Cdr. Sandeep Kumar (Retd.), IRS; Shri Lokanath Tripathy from Great Ship; Shri Nebu Oommen, Dy.CSS, DGS; and Capt. Mahesh Yadav from FOSMA, each contributing their expertise to the deliberations on the crucial framework.



A special session by the Indian Ports Association (IPA) highlighted preparations for the upcoming India Maritime Week 2025.

The workshop concluded with a summing-up by **Shri David Birwadkar**, who reiterated the need for India to become a proactive architect of maritime regulation. He outlined three



regulation. He outlined three objectives: demystifying IMO policy processes, strengthening partnerships across the maritime ecosystem, and catalyzing progress through collective resolve. **Shri Santosh Patil** of IRS delivered the vote of thanks.



Overall, the workshop underscored a strong national consensus: India must assert itself at IMO with permanent representation, enhanced industry-government-academia collaboration, and a unified voice to safeguard national interests while contributing to safe, sustainable, and equitable global maritime governance.

VLCC

After having roared into the WS 80's MEG/East rates have dropped back into the low WS 70's, by and large led by oilco-trader relets taking a less aggressive stand, simultaneously making it more palatable when having the "buyer" hat on. That said, an offer a few weeks back of something starting with a 7 for September loading dates would have endangered the offering hand. However, the question is whether it's sustainable or if we'll see a further downward pressure. The "official" cargo board was wanting this morning and with a fixture count around the 140 mark we're approaching the end of the month's program with October stems not due out before next week. The Atlantic, however, is still a healthy alternative with USG exports continuing to "pump, baby, pump", albeit date sensitive. And geopolitical tensions are not making predictions any easier to say the least.

Suezmax

Despite lacklustre volumes overall ex West Africa (we are on track to take at least 10MBBLs less on Suezmax close to 20% - in September, compared to a standard month) upsizing US Gulf stems on top of Liza & Brazil moves have contrived to sustain market levels, whilst active CPC and MEG markets continue to fire, all keeping lists condensed. The front end remains very sparse for TD20, just 5 ships roughly FOC, but with supplementation inbound over the weekend and dates fixed sufficiently forwards that charterers will be reluctant to pay up further than WS 110-112.5 levels which have fixed this week. Whilst in the US Gulf, Aframax levels are unlikely to drive further spillover, VLCC rates remain strongly in excess of Suezmax on a 1 parcel basis and additional export volume from the MEG may drive more USG/TA moves and TD20 runs which could help sustain the market in the medium term. From an earnings perspective levels ex West Africa are sufficient to underline owners attempts to keep the MEG at WS120 eastbound on modern tonnage and circa WS 60 westbound via COGH.

Aframax

A handful of cargoes have been worked so far this week in the North Sea and rates have been corrected downward. Still some prompt vessels that needs to find employment, but some of them might find alternatives in the USG where rates been pushing up again for a usg/ta run. But even with some ships ballasting towards usg, we don't expect rates in the North Sea to change anytime soon.

The Mediterranean market has been going sideways with limited activity and charterers reaching a bit datewise with some already looking for cover well into the 3rd decade of September. The tonnage list looks fairly balanced with some vessels ballasting out of the area and some ballasting in from a lackluster Cont market. Trend is still sideways, but with a downward pressure unless we see an increased activity level.

Dry Bulk

Capesize

On the C5 front, we see miners, operators and some tenders alike out for late September to early October dates. Volumes out of other fronts of the Pacific are rather

flat. On C3 ex Brazil and West Africa, cargo enquiries remain for split dates and second half of October dates primarily. Spot tonnage out of Far East is beginning to tighten. On ballasters, we see some vessels left for split dates and heavily weighted on first half October dates. We see C5 concluding at tick above mid USD 10 pmt levels. On C3, fixtures concluded at mid USD 23 pmt levels for split dates.

Panamax

The Panamax market sustained its upward momentum this week, with the Atlantic continuing to show strong fundamentals. Tight nearby tonnage and firm mineral demand from the USEC, Colombia, and Baltic supported higher ideas, while ECSA remained more balanced but still saw P6 supported by October spot requirements. In the Pacific, fresh demand from NoPac and Australia, coupled with consistent Indonesian coal activity, kept sentiment buoyant, with charterers actively chasing coverage and owners holding the upper hand. Although some resistance remains on the bid side, the overall tone across both basins is firmly bullish, underpinned by resilient demand and limited tonnage availability, with market participants watching October volumes closely to assess whether current strength can be sustained.

Supramax

The Atlantic Supramax and Handysize markets showed a generally firm tone, though momentum varied across regions. In the US Gulf, Supramax sentiment remained positive with stronger levels being discussed, while Handysize activity was subdued and continued to trend softer. The South Atlantic was the standout, where both sizes benefited from tighter tonnage lists and healthy demand, supporting firmer sentiment and encouraging charterers to bid higher. The Continent–Mediterranean remained finely balanced, with little fresh cargoes in the Supramaxes and only modest improvements on the Handysize side.

Gas Chartering EAST/WEST

The earnings gap between East and West continues to widen, driven by robust US fixing activity and a relatively quiet week in the East, where many market participants are attending APPEC events and meetings in Singapore. A noticeable shift is emerging as more Chinese-controlled vessels seek cargos in the East, aiming to avoid exposure to US and the upcoming USTR penalties. With USTR measures expected to take effect in just over a month, a new normal in the East-West earnings spread may be expected to persist for a while. Meanwhile, the recent attack on Qatari soil is currently looking unlikely to impact security in the Strait of Hormuz, though the situation remains under close observation.

An under fixed October US market took a run at the start of the week following the fixing spree in the Middle East week prior. Shipping positions East and West of Suez goes hand in hand as long as the majority of vessels ballast via Cape, leaving little or no surprises when it comes the visibility of vessel ETAs. At the time of writing there are very few relets in the USG for second half October, which subsequently sets expectation of a strong market to continue throughout the month.



Mozambique advances legal framework for maritime security

Mozambique is strengthening its maritime security by taking steps to further integrate international IMO maritime security instruments into national laws with technical support from the International Maritime Organization.

A legal review workshop provided support to staff of the Ministries of Transport and Maritime Affairs Authorities in domesticating IMO



The ISPS Code provides a framework for a standardized mandatory security regime for international shipping, and for the exchange and evaluation of information between contracting governments, companies, port facilities and ships.

This workshop was a follow up to the first legal review workshop as part of the EU-funded project on Port Security and Safety of Navigation in Eastern and Southern Africa and the Indian Ocean. Through the project, IMO supports nine participating countries, Mozambique included, in advancing maritime security and safety in line with the aspirations of the 2050 Africa's Integrated Maritime Strategy.

The workshop was opened by Mr. Simiááo Munguambe, Executive Administrator, ITRANSMAR and is being attended by twenty six (26) participants from various agencies including Alfândegas de Moçambique/Customs, Attorney General Office (PGR), Maritime Transport Institution (ITRANSMAR, IP), Escola Superior de Ciencias Náuticas/Nautical School, Ministry of Transport, Ministério da Justiça, Assuntos Constitucionais Religiosos/ Ministry of Justice, Constitutional and Religious Affairs, Instituto Ferro-Portuario de Moçambique (IFEPOM)/ Mozambique Railway and Port Institute, Marinha de Guerra de Moçambique/Navy, Tribunal Marítimo/Maritime Court, Mozambican Coastal, Lake and Riverine Police (PCLF).

This initiative was delivered in close collaboration with strategic partners the Indian Ocean Commission (IOC), INTERPOL, and the United Nations Office on Drugs and Crime (UNODC).

Truckers declare Indefinite Strike at Kandla and Mundra, Cargo Flow set to Halt

Cargo movement at Kandla and Mundra, India's busiest twin ports, is expected to grind to a halt as truckers' unions announced an indefinite strike beginning this weekend. The decision was communicated through a circular issued by the Joint Forum of Truck Owners and Operators, representing transporters across the Kutch region.

The forum stated that the suspension of operations comes after years of what they described as neglected concerns over deteriorating road conditions, inadequate highway safety measures, and several long-standing demands of the transport community that remain unresolved.

Stopping services was not a preference, but a necessity, the forum noted, emphasizing that the move was taken in the larger interest of sustainable trade and transport operations.

In a direct message to the authorities, the truckers raised the slogan "No Road, No Toll", questioning why they should continue paying highway tolls when, according to them, the National Highway Authority of India has failed to maintain proper roads. The unions emphasized that this will remain a peaceful protest, but one aimed at holding officials accountable for years of inaction.

Industry bodies have been advised to plan shipments in advance and complete urgent cargo movements before the strike begins, as disruptions at these two ports could ripple across India's international trade supply chain. Kandla and Mundra handle a significant share of containerized and bulk cargo for both imports and exports.



Ratifying and implementing the BBNJ **Agreement Event at UN Headquarters**

The World Maritime University - Sasakawa Global Ocean Institute (WMU-GOI) in collaboration with the International Coastal and Ocean Organization (ICO) Global Ocean Forum (GOF), hosted a side event during the second session of the BBNJ Agreement Preparatory Commission (PrepCom II), held at the UN Headquarters in New York.



The event, titled "Ratifying and Implementing the BBNJ Agreement: Efforts and Challenges", brought together leaders and experts from Small Island Developing States (SIDS) and other developing countries to discuss national and regional efforts. challenges in ratification and implementation, and ongoing capacity development initiatives. The WMU-GOI contribution was organized within the Ireland WMU-GOI BBNJ Clinic Programme, funded through the Government of Ireland International Development Programme.

The BBNJ Treaty, formally the Agreement on Marine Biological Diversity of Areas beyond National Jurisdiction, is an international treaty under the United Nations Convention on the Law of the Sea (UNCLOS) adopted in 2023 to provide a framework for the conservation and sustainable use of marine biodiversity in the high seas.

Keynote remarks were delivered by Ambassador Nuala Ní Mhuircheartaigh, Deputy Permanent Representative of Ireland to the UN, who stressed the BBNJ Agreement's importance for ocean protection and its complementarity with other conventions and agreements.

The first panel was moderated by WMU-GOI Director, Professor Ronán Long, and Assistant Professor Dr. Ríán Derrig. The panel explored domestic implementation needs under the Agreement and emphasized knowledge-sharing among SIDS, with speakers addressing Pacific regional coordination, nationallevel implementation, marine genetic resources, and environmental impact assessments.

The second panel focused on collaboration, advocacy, and capacity development to support ratification, highlighting the importance of cross-sectoral governance platforms, active stakeholder participation in Latin America, and the role of financial support and global initiatives in advancing these efforts.

Closing remarks from Ms. Susan Gardner (UNEP) emphasized the need for cross-sectoral and intergenerational collaboration to ensure inclusive participation, especially from SIDS and developing countries and to address the legal, institutional, and technical foundations necessary for effective implementation of the BBNJ Agreement.

The Directorate General of Shipping is pleased to inform that five Indian seafarers serving onboard MV ANKA, Capt. Soumen Saha (Master), Milon Das (Chief Officer), Rishab Arora (Second Engineer), and two ABs have been successfully repatriated and returned safely to India on 27th August 2025.

The vessel was detained by the Ukrainian Secret Service Department at RENI in April 2025. During this period, the crew faced prolonged hardship due to non-payment of wages and irregular supply of provisions. Through sustained efforts of the Ministry of External Affairs, India (MEA), Embassy of India in Kyiv, Ministry of Ports, Shipping and Waterways (India) (MoPSW), Directorate General of Shipping (DG Shipping), ITF London, MUI India, and NUSI crew received their pending wages under insurance cover and were safely repatriated via Moldova.

This successful resolution reflects the Government of India's unwavering commitment to the safety, welfare, and rights of Indian seafarers wherever they may serve. DG Shipping acknowledges the courage of the seafarers and the cooperation of all agencies and stakeholders who worked together to ensure their safe return.

Shri Pralhad Joshi inaugurates 1st Green Hydrogen R&D Conference

Union Minister of New and Renewable Energy, Shri Pralhad Joshi, inaugurated the 1st Annual Green Hydrogen R&D Conference organised by Ministry of New and Renewable Energy in New Delhi and launched a new ₹100 crore Call for Proposals to support start-ups in hydrogen innovation. The scheme will provide up to ₹5 crore per project for pilot projects in innovative hydrogen production, storage, transport and utilisation technologies. At the conference, 25 start-ups are showcasing their innovations, ranging from electrolyser manufacturing to Al-driven optimisation and biological hydrogen solutions.

Addressing researchers, start-ups, industry leaders and policymakers, Shri Joshi emphasised that the conference is not just about sharing ideas but about turning research into practical solutions that can power industries, clean cities, and create lakhs of new jobs across India. He underscored the vision of Prime Minister Shri Narendra Modi, who launched the National Green Hydrogen Mission (NGHM) in 2023, to transform India's energy landscape and make the country a global hub

for green hydrogen. With an outlay of ₹19,744 crore, the Mission rests on four pillars – Policy and Regulatory Framework, Demand Creation, R&D and Innovation, and Enabling Infrastructure.

Shri Joshi stressed that green hydrogen ecosystem in India is already moving from vision to action. India's first port-based Green Hydrogen Pilot Project has been launched at V.O. Chidambaranar Port in Tamil Nadu. In the steel sector, five pilot projects are demonstrating hydrogen-based decarbonisation. In shipping, vessels are being retrofitted and refuelling facilities are being developed at Tuticorin Port. In transport, hydrogen buses and refuelling stations are already operational. In fertilisers, India conducted its first-ever green ammonia auction, discovering a historic low price of ₹49.75 per kg, compared to ₹100.28 per kg in 2024, with supplies set to begin at Paradeep Phosphates in Odisha.

The Minister further highlighted the enablers already in place, including the Green Hydrogen Standard and Certification Scheme aligned with over 140 international standards, sanctioning of five new testing facilities, certification of more than 5,600 trainees in hydrogen-related qualifications, and regulatory waivers such as transmission charge exemptions and streamlined clearances. **Dedicated hydrogen hubs are being developed at Kandla, Paradip and Tuticorin Ports to strengthen India's export competitiveness.** He added that both large enterprises like NTPC, Reliance and IOCL and start-ups and MSMEs are investing heavily in hydrogen, building a robust value chain and creating lakhs of new jobs.

Addressing the inaugural session, Principal Scientific Adviser to the Government of India, Prof. Ajay Kumar Sood said that R&D empowers the nation to solve complex challenges and drive economic growth. "R&D is not optional, but essential," Prof. Sood said, stressing the importance of sustained innovation for building a robust green hydrogen ecosystem.

MNRE Secretary Shri Santosh Kumar Sarangi highlighted that the Green Hydrogen R&D programme has a budgetary outlay of ₹400 crore and that MNRE is ready to collaborate and support all stakeholders in driving forward the National Green Hydrogen Mission.

Mission Director of the National Green Hydrogen Mission, Dr. Abhay Bhakre, said that India today stands at the threshold of becoming a global leader in green hydrogen.
