ORDER

Whereas, M/s Siddhi Vinayak Professional Academy Private Limited [hereinafter to be referred as "RPS agency"] was issued with Recruitment & Placement Service License bearing No. RPSL-MUM-465 valid from 22.05.2024 to 22.05.2029 by the Director, Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016.

2. And whereas, it was observed that RPS agency had failed to undergo Annual Inspection for the years 2024 and 2025 within stipulated time-limit and therefore, is observed to be in violation of Rule 5(1)(z) and Rule 13(2) of M.S. (R&PS) Rules, 2016 to be read with Para 1.8 of DGS Crew Br. Circular No. 03 of 2016 dated 23.08.2016.

3. And whereas, a show cause notice under Rule 12(1) of M.S. (R&PS) Rules, 2016 was issued to RPS agency vide this office letter No. 35321-MMDMUM-14011(16)/1/2025/435/2025 dated 31.07.2025 for the observed violations mentioned vide Para 2 above. In reply, RPS agency submitted response to the same vide letter dated 26.08.2025 received in this office vide email dated 30.08.2025.

4. And whereas, this office vide email dated 24.09.2025 scheduled Personal Hearing with RPS agency under Rule 12(2) of MS (RPS) Rules, 2016 on 26.09.2025. However, RPS agency requested for Virtual Hearing expressing inability to attend Personal Hearing due to medical condition. Subsequently, a final Hearing in the matter was scheduled on 28.11.2025 vide this office letter of even number dated 25.11.2025 which was also issued vide email to the registered mail ID of RPS agency on the same date (2:35:42 PM). However, neither any representative of RPS agency reported for the hearing nor any intimation in this regard was received from RPS agency by this office.

5. Therefore, it is concluded herein that RPS agency has no valid explanation to tender and it is evident from all the above that said RPS agency is guilty of conducting its affairs

in violations of Rule 5 in toto of Merchant Shipping (Recruitment & Placement of Seafarer) Rules, 2016 promulgated vide Gazette Notification GSR No. 169 (E) dated 15.02.2016 and Merchant Shipping (Maritime Labour) Rules, 2016.

6. Based upon detailed proceedings conducted in the aforesaid matters and in view of all the above, the Director Seamen's Employment Office exercising the power vested in accordance with Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarer) Rules, 2016 orders following:

6.1 Recruitment and Placement Service (RPS) License bearing No. RPSL-MUM-465 in respect of M/s Siddhi Vinayak Professional Academy Private Limited is hereby WITHDRAWN with immediate effect by the Director, Seamen's Employment Office, Mumbai in terms of Rule 12 of Merchant Shipping (Recruitment & Placement of Seafarer) Rules, 2016.

6.2 M/s Siddhi Vinayak Professional Academy Private Limited & its associated Directors continue to remain liable for the seafarers who have already been recruited by them and those who are presently serving onboard.

6.3 The submitted Bank Guarantee amounting to INR 10,00,000/- (INR Ten Lacs Only) of M/s Siddhi Vinayak Professional Academy Private Limited is hereby withheld under custody of this office for any contingent issue due to default / violation of extant M.S. (R&PS) Rules, 2016 in terms of provisions of Rule 15 of MS (R&PS) Rules. 2016 inter-alia under sub-rule 5(c) of Rule 15 of MS (R&PS) Rules. 2016.

7. If, M/s Siddhi Vinayak Professional Academy Private Limited, feels aggrieved by the order passed herein, it may within a period of thirty (30) days of receipt of this order, prefer 1st appeal to the Principal Officer, Mercantile Marine Department, Mumbai, being the First Appellate Authority in the matter, in accordance with Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016. [It may be noted that Rule 18 mentioned under Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 is to be read as Rule 12 view typographical error in Gazette Notification No. G.S.R. 169 (E) dated 15.02.2016].
