As Chief Examiner of Master & Mates, I'm pleased to present the 2024 Annual STCW Report for the Nautical Wing. This reflects the maritime community's commitment to high training and certification standards. With the industry evolving rapidly, the STCW Convention remains key in preparing mariners for modern challenges in technology, safety, and sustainability.

I am particularly heartened to highlight some of the remarkable achievements detailed in this report:

- A record-breaking 3,597 Certificate of Competency (COCs) for foreign-going vessels were issued in 2024,
 marking the highest in the past five years.
- A total of 10,840 COPs including 7,550 Deck Watchkeeping and 3,290 Able Seafarers Deck COPs were issued in 2024 for Deck Ratings. A total of 22,654 DCEs were issued for Tanker Operations reinforcing job readiness and specialised safety training.
- MMD Mumbai recorded a five-year high in 2024, issuing 68 Basic COPs for POLAR Water Operations and 50 Advanced COPs for POLAR Water Operations.
- Training institutes demonstrated strong outcomes in 2024, with high passing percentage: Second Mate –
 73.24%, First Mate Phase I 72.4%, First Mate Phase II 76.67%, and Master FG 77.27%.
- In a first, 2,006 certificates were endorsed in 2024 by the Directorate General of Shipping for Indian Naval personnel shifting to the Merchant Navy.

These statistics highlight the growing global competitiveness of Indian seafarers, with improving pass rates reflecting effective training and candidate commitment. However, variations across programs, especially NCV pass rates ranging from 56.98% to 65.42%, indicate scope for improvement. There is also a need to increase NCV-grade officers to support coastal shipping, and the Directorate remains committed to promoting this through a focused approach.

I thank the administration, training institutes, examiners, and especially our seafarers for their dedication. Their efforts help India produce skilled mariners who uphold the highest standards. Moving forward, let's use this report's insights to strengthen training, refine certification, and promote safer, more sustainable maritime operations.

1.INTRODUCTION

1.1 Overview of STCW Certification and its Importance.

The Standards of Training, Certification, and Watchkeeping for Seafarers (STCW) Convention, established by the International Maritime Organization (IMO), represents a coherent and globally recognized framework for ensuring the competence of maritime professionals. It defines essential requirements for training, certification, and watchkeeping, thereby reinforcing the operational safety and regulatory compliance of vessels across international waters.

At its core, the STCW Convention is designed to ensure that seafarers possess the requisite knowledge, skills, and qualifications to perform their duties effectively. In doing so, it promotes a culture of safety, safeguards marine environments, and enhances the overall well-being of personnel working at sea. By standardizing these expectations across jurisdictions, the Convention serves as a critical instrument in preventing incidents, reducing risk exposure, and maintaining seamless maritime operations.

In the context of ongoing technological advancements and evolving environmental and safety regulations, the relevance of STCW certification has become increasingly strategic. It not only certifies individual competence but also builds institutional confidence in a workforce that must adapt continuously to complex and dynamic maritime challenges. Thus, STCW functions not merely as a compliance standard, but as a catalyst for operational excellence and global interoperability in seafaring practice.

1.2 Purpose of the Report

The Annual STCW Report 2024 presents a comprehensive account of the Directorate General of Shipping's certification and training initiatives undertaken between January and December. It compiles data on the issuance of Certificate of Competency (COCs), Certificate of Proficiency (COPs), and various Dangerous Cargo Endorsements (DCEs). In addition, the report highlights measures implemented to ensure compliance with international standards. including inspection protocols. administrative actions, and regulatory improvements. These efforts underscore the Directorate's role in reinforcing a robust and accountable certification system aligned with the evolving needs of the maritime sector.

It evaluates institutional outcomes based on pass rate trends, instructional quality, examination infrastructure capacity. and efficiency. 1.3 Executive Summary

Overview

The STCW Annual Report 2024 offers a comprehensive and carefully curated overview of the maritime administration's certification activities and accomplishments throughout the past year. Demonstrating a steadfast commitment to excellence, the report highlights significant advancements in training, a marked increase in certificate issuance, and strengthened quality assurance processes.

Certificate of Competency (COC) – Issued in 2024



A total of 3,597 Certificate of Competency (COC) were issued for foreign-going vessels, marking a slight but notable increase from 3,559 in 2023. This represents a 1.07% year-on-year growth, making it the highest number issued in the last five years.



2,788 GMDSS Certificate of Competency were issued through MMD Mumbai. While all MMDs remained active in certification efforts, Mumbai handled a comparatively higher volume within the overall framework.

COP Deck Ratings – Overview

- A total of 10,840 Certificate of Proficiency were granted in 2024.
- This reinforced the global readiness and credibility of the Indian seafaring workforce.
- This upward trend in certifications has further enhanced the global employability of Indian seafarers.



- In 2024, 2,006 certificates were issued to Indian Naval personnel joining the Merchant Navy the highest ever in a year.
- This initiative expanded employment avenues while enriching the merchant fleet with skilled manpower.




In 2024, a record total of 3,597 Certificate of Competency (COCs) were issued, reflecting an overall upward trend in certifications. This increase indicates:

In 2024, a total of 63 Certificate of Competency were issued for Near-Coastal Voyages, demonstrating continued engagement in meeting regulatory requirements for maritime operations.

2.3 Certificate of Competency and certificates endorsed issued to Indian Navy Personnel

2.3.1: Certificate of Competency

- ▶ In a landmark move under DGS Order 17 of 2022, the Directorate General of Shipping began issuing STCW Certificate of Competency (COC) to eligible Indian Naval officers transitioning to the Merchant Navy.
- ➤ The first CoC under this order was issued on 10 March 2025, marking a significant step toward bridging defense and merchant maritime operations.

2.3.2: Certificates endorsed for Naval personnel

In 2024, for the first time, the Directorate General of Shipping endorsed 2,006 certificates enabling Indian Naval personnel to transition to the Merchant Navy, in accordance with DGS Orders 16 and 17 of 2022.









PERFORMANCE OF MARITIME TRAINING INSTITUTES

1.INTRODUCTION

1.1. Overview of Program

The Indian maritime sector continues to play a vital role in global seafaring and trade, with a robust training infrastructure underpinning its human resource strength. The Annual Training Institute Report – 2024 presents a detailed overview of candidate outcomes from leading maritime institutions across the country. This year's analysis encapsulates a wide spectrum of competency examinations, covering certifications from entry-level navigational roles to command-level ranks, reflecting the continued commitment to structured seafarer development.

The report evaluates examination performance under the following key certification tracks:

- Second Mate of a Foreign Going Ship
- First Mate (Foreign Going) Phase I & Phase II
- Master (Foreign Going)
- Master NCV, First Mate NCV, and NWKO NCV

Each program featured in the report represents a crucial milestone in the structured progression of officer's deck career, beginning foundational sea-time qualifications to advanced command-level readiness. These certifications designed test both theoretical are to understanding and practical competencies required at sea. By evaluating outcomes across these key categories, the report offers insights into how effectively training institutes equipping candidates to meet stringent industry and regulatory benchmarks.

The performance data has been carefully analyzed with respect to pass percentages, the number of participating candidates, and the share of representation across institutes. This year's findings reveal a diverse pattern, while a few institutes maintained consistent performance with high pass rates, others showed irregular outcomes, suggesting the need for tailored academic support or infrastructural enhancements. The variation points differences in institutional preparedness, faculty delivery standards, and the candidates' overall readiness for assessments.

Moving beyond just success rates or rankings, this report emphasizes broader performance patterns and systemic insights across the training landscape. allows maritime lt stakeholders including academic leaders and to pinpoint specific gaps and policy bodies opportunities for refinement. By focusing on underlying issues rather than surface outcomes, the goal is to promote sustainable, data-driven improvements that can help institutes realign teaching strategies, invest faculty development, and better prepare candidates for certification.

Ultimately, this report serves not only as a reflection of candidate performance but also as a benchmark for institutional accountability and progress. It provides an informed basis for regulators, training institutions, and maritime authorities to collaboratively enhance the quality and consistency of maritime education. As demand for globally competent officers continues to grow, such assessments play a vital role in guiding collective improvement and policy evolution within the training ecosystem.

The analysis reflects the ongoing commitment of maritime authorities to uphold high training standards, improve examination success, and ensure the readiness of Indian seafarers for global maritime operations.

Key Certifications Overview



Second Mate (Foreign-Going)

Anglo Eastern (New Delhi) achieved the highest pass rate of 73.24% among all institutes offering the Second Mate (FG) program, reflecting strong academic delivery and candidate preparedness.

First Mate (Foreign-Going)

SHAPE (Panchkula) recorded the highest pass rate in Phase I at 72.4%, reflecting strong academic delivery across both phases.




Master (Foreign-Going)

2024 - MASSA (Chennai) achieved the highest pass rate of 77.27%, demonstrating excellence in advanced maritime training and preparation for senior seafaring roles.

Near-Coastal Voyage (NCV)

Certification Outcomes - 2024

A total of 1,092 candidates successfully passed the NCV certification examinations in 2024 The pass rates for NCV programs are as follows:







FOSMA Noida recorded the highest number of candidates appearing for these exams

Pass Rate Trends: 2023 vs 2024



First Mate NCV Phase I pass rate jumped from 25% (2023) to 64.27% (2024) — a sharp improvement.



First Mate (FG) Phase II also registered strong growth, increasing from 69.94% to 76.67% year over year.



Master NCV showed a decline, with pass rates dropping from 61.70% in 2023 to 56.98% in 2024.

The analysis of the performance data in this report identifies both the strengths and areas needing improvement across various maritime training institutes. This information is crucial for implementing best practices and addressing gaps, ultimately enhancing the quality of maritime education and training.

2. Second Mate of a Foreign Going Ship

Performance trends in the 2024 Second Mate (Foreign Going) examinations reflected strong outcomes in core navigation subjects, especially Meteorology and Celestial Navigation. In contrast, Cargo Handling and Ship Operation continued to see lower pass rates, highlighting gaps in practical competencies. While a few institutes achieved consistently high results, the overall spread revealed marked differences in training standards across the sector.



Institutes like Anglo Eastern (New Delhi) and FOSMA Kolkata performed strongly across key subjects, excelling in Meteorology, Celestial Navigation, and Bridge Watchkeeping. Applied Research (New Delhi) also showed consistent results across both navigation and operational areas. In contrast, IMU Mumbai and Hoon Maritime (Kolkata) recorded lower pass rates, particularly in Cargo Handling and Ship Operation, pointing to gaps in practical training delivery.

Pass Rate by Subject – Key Trends

Meteorology led with the highest pass rate, followed by Celestial Navigation and Bridge Watchkeeping, indicating strong academic grounding. While Ship Operation and Cargo Handling saw comparatively lower results, they highlight areas with greater scope for practical learning and development.



Key Highlights

- Meteorology and Celestial Navigation saw the highest success rates across institutes
- FOSMA and Applied Research maintained consistent results across high candidate volumes.
- Over 70% pass rate was achieved by only three institutes, showing a narrow top-performing







3. First Mate of Foreign Going Ship Phase 1

Summary

The 2024 Phase I examination for First Mate (Foreign Going) presented a diverse range of outcomes across maritime training institutes. While academic subjects such as Meteorology continued to yield high success rates, operational areas like Cargo Handling and ARC Navigation saw mixed performance. Institutes like SHAPE Panchkula and Applied Research New Delhi showcased consistent performance across all subjects, while a few others struggled to maintain uniform results across both academic and practical modules. Overall, this phase highlighted both excellence in specialized instruction and noticeable disparities in foundational areas across institutes.

Top-Performing Maritime Academies



While all five institutes secured high overall averages, the patterns of strength varied. SHAPE Panchkula displayed well-rounded results, with pass rates consistently above 85% in Meteorology, Ship Operation, and Cargo Handling. Applied Research New Delhi mirrored this balance but slightly lagged in Cargo subjects. FOSMA Kolkata and Noida demonstrated strong theoretical grounding, particularly in Meteorology (over 85%), yet showed dips in Cargo and Navigation Application papers. Meanwhile, Euro Tech Cochin stood out for its uniformity across the board, maintaining solid mid- to high-range pass percentages without sharp fluctuations — a mark of steady, if not standout, subject delivery.

Key Highlights

- ➤ Naval Architecture Paper–1 showed a distinct variation in pass rates, ranging from 33.3% to 72.93% across institutions.
- ► IMER Patna and IMU Mumbai recorded average scores below 55%, highlighting a notable gap in overall student outcomes.



4.First Mate Of a Foreign Going Ship Phase-2

Summary

The Phase 2 training data reflects several positive trends across maritime institutes. Many institutes such as SHAPE Panchkula, FOSMA Kolkata, and MASSA Navi Mumbai have demonstrated strong and consistent performance across critical subjects like BWK and Engg.Knowledge, indicating effective training delivery and student preparedness. Subjects like Engg.Knowledge and BWK show encouraging results across most institutes, suggesting a solid grasp of core operational concepts. Even among institutes with lower overall scores, there are individual subjects where performance is commendable, highlighting focused strengths. Overall, the data showcases a promising foundation in maritime education, with opportunities to further strengthen subject-specific training and bring greater consistency across institutes.





5. Master of a Foreign Going Ship

Summary:

The performance in the Advanced Shipboard Management (Written) examination shows encouraging trends across several maritime institutes, with a few achieving remarkable success. While some institutes achieved excellent outcomes, others demonstrated moderate success, and a few lagged behind. Overall, the data suggests that many institutions maintain a fair level of academic effectiveness in delivering advanced maritime training. The variations in pass rates underscore the need to standardize teaching practices and strengthen subject-specific support to ensure more consistent performance across all centers. Institutes such as Massa Maritime Academy (Chennai) and Mumbai Maritime Training Institute lead with strong pass rates, reflecting high standards of academic delivery and student preparedness.

Participation Scale in Advanced Shipboard Management Examination

A total of 1,453 candidates appeared for the Advanced Shipboard Management written examination across all listed institutes. Notably, FOSMA Noida contributed the highest share with 185 examinees, followed closely by MASSA Maritime Academy (Navi Mumbai) with 174, and Applied Research International (New Delhi) with 103. These figures reflect the significant scale of operations at these leading institutes and their central role in shaping the Master-level officer cadre for the maritime sector.
