B. Nomination Guidelines

1. Nomination Channels:

- o Online Submission: Through the link available on official DGS website portal.
- o Internal Nominations: By Directorate General of Shipping officials, based on merit.

2. Eligibility:

- Open to Indian individuals, institutions, companies, NGOs, and government bodies engaged in maritime activities.
- Foreign entities may be considered only if their contribution significantly benefits India's maritime sector.

3. Nomination Package Requirements:

- Completed Nomination Form Format as google form <u>link</u>. (https://forms.gle/4gwwXvuhJtvy9LGV8)
- o A brief statement (max 500 words) on why the nominee deserves the award.
- Supporting documents: photographs, reports, testimonials, or media coverage (if applicable).

 Endorsement letter from a recognised authority/organisation (optional for selfnominations, mandatory for internal nominations).

4. Submission Deadline:

- All nominations must be received within the announced submission window. The final date for submission is 22nd August 2025.
- Late entries will not be considered.
- o The evaluation to be completed by 28th August 2025.
- All nominations must be received within the announced submission window. Late entries will not be considered.

C. Evaluation Process

1. Pre-Screening:

DGS Secretariat will verify eligibility and completeness of applications.

2. Evaluation Committee:

o A Committee constituted by the Directorate General of Shipping, comprising senior maritime experts, will assess the nominations using the **Marking Scheme** in Section A.

3. Scoring:

- o Each nomination will be scored independently by all committee members.
- o Scores will be averaged to determine final ranking in each category.

4. Tie-Breaking:

 In case of a tie, preference will be given to entries demonstrating highest sectoral impact and replicability.

5. Final Approval:

 Recommendations of the Evaluation Committee will be submitted to the Directorate General of Shipping for final approval.

6. Announcement & Ceremony:

o Awardees will be notified in advance and felicitated during the 75 Years Commemorative Celebration Main Event.

D. General Terms

- The Evaluation Committee reserves the right to withhold an award in any category if no nomination meets the required standards.
- Decisions of the Directorate General of Shipping shall be final and binding.
- All submitted materials become the property of the Directorate General of Shipping and will not be returned.
