Shri Deependra Singh Bisen, DDG will also hold the charge of the Member Secretary to the STCW Compliance Board, which hitherto was carried by Dr. Sudhir Kohakade, DDG, and shall also look after the Maritime Training Trust processes in DG Shipping and shall be designated as the DDG, Training.
