## **Note:**

- 1. **Blocked**: DG Shipping e-Governance online privileges of the RPS agency have been **blocked** for signing-on seafarers, pending the issuance of a Show Cause Notice (SCN) and further investigation. However, the RPS agency is permitted to sign off seafarers who were onboarded or e-migrated through their agency.
- 2. **Suspended**: Following the issuance of the Show Cause Notice (SCN) and subsequent investigations, the licence of the concerned RPS agency has been **suspended** by the Competent Authority for a specified period
- 3. **Withdrawn**: Following the issuance of the Show Cause Notice (SCN) and subsequent investigations, the RPS license granted to the concerned RPS agency has been **permanently revoked** by the Competent Authority
