Subject: Blacklisting of Vessels Involved in Seafarer Abandonment / Jailed / Arrested

Cases – reg.

Date:05.09.2025

Background - The Directorate General of Shipping (DGS) has been receiving repeated complaints and reports of abandonment, detention, or arrest of Indian seafarers on certain vessels. A majority of these vessels are operating without minimum mandatory documents, including valid P&I insurance cover, and in many cases, no response is received from the respective Flag States or Port States when approached. The situation is further aggravated by poor compliance from certain RPSL companies, with some vessels operating without proper Form—1 documentation for seafarers. Consequently, Indian seafarers and their families become the ultimate sufferers in abandonment cases—facing prolonged hardship, denial of wages, uncertainty of repatriation, and immense psychological distress. Such incidents not only cause severe hardship to seafarers and their families but also undermine India's obligations under the Maritime Labour Convention, 2006 (MLC), particularly in ensuring decent working conditions, repatriation, and wage protection.

- 2. Investigations and reviews of the abandonment cases carried out by the Director, Seamen's Employment Offices (DSEO), and Crew Branch of the DGS have revealed that a number of vessels are recurrently involved in abandonment cases, where Indian seafarers have suffered due to:
 - i. Non-payment of wages,
 - ii. Lack of repatriation support, and
 - iii. Inhuman and unsafe working conditions
 - iv. Detention by port authorities / by local agents / cheating & fraud cases.
 - v. Lack of genuine ship owners / non availability of ship owners.
 - vi. Lack of Insurance coverage / providers.

- vii. Lack of proper statutory documentation
- 3. A total of eighty-six (86) vessels has been identified up to the year 2025, based on the gravity, recurrence, and enforcement challenges. Show Cause Notices have also been issued to several RPSL companies linked to such vessels.
- 4. Considering the seriousness of the matter, and in exercise of powers under Section 456 of the Merchant Shipping Act, 1958, Regulations 2.5, 2.6 and 4.1 of the MLC, 2006, and the Recruitment and Placement of Seafarers Rules, 2016, this Directorate hereby issues the following directive.
 - a. The vessels listed in Annexure I are hereby blacklisted with immediate effect.
 - b. No RPSL company shall recruit, engage, or deploy Indian seafarers on board the blacklisted vessels henceforth.
 - c. Where Indian seafarers are presently serving on board such vessels, the concerned RPSL shall ensure:
 - i. Prompt sign-off at the earliest possible port of call, and
 - ii. Safe repatriation to India with settlement of wages, health, and welfare entitlements.
 - d. All RPSL companies which have deployed Indian seafarers on these vessels (past or present) shall submit a detailed report to this Directorate within fourteen (14) working days of issuance of this Circular, including:
 - i. Names, INDOS and CDC Numbers of seafarers deployed,
 - ii. Period(s) of employment,
 - iii. Repatriation status, and
 - iv. Wages paid / outstanding with documentary evidence.
 - e. Failure to comply with these directives shall attract strict penal action, including but not limited to:
 - i. Suspension / Cancellation of RPSL licence as per MS Notice 11 of 2024 / RPSL Rules, 2016.
 - ii. Blacklisting of the agency, and
 - iii. Legal proceedings under the Merchant Shipping Act, 1958 and relevant MLC provisions.

5. This Circular is issued in the interest of protection of the rights, dignity and welfare of Indian seafarers, and to ensure India's strict adherence to its international commitments under the MLC, 2006. All stakeholders are directed to comply without exception.
