- 1. Safe navigation of Indian ships, their safety and security is paramount to the Directorate General of Shipping (DGS), the competent authority of the Government of India for maritime affairs. To ensure that a ship is sufficiently, effectively, and efficiently manned to provide for the safety and security of the ship, safe navigation, and operations at sea, and to ensure the welfare and health and for avoidance of fatigue, safe manning of ships is essential.
- 2. In this regard, Guidelines have been provided by the International Maritime Organization (IMO) through Resolution A.1047(27) on the Principles of Minimum Safe Manning. Additionally, Regulation 14 of Chapter V of the International Convention for the Safety of Life at Sea (SOLAS) specifically addresses the requirement of safe manning on ships.
- 3. Section 76 of the Merchant Shipping Act, 1958 mandates that every ship, whether at sea or in any port, shall engage such number of persons with such qualifications as may be prescribed. Further, Rule 14 of the Merchant Shipping (Safety of Navigation) Rules, 1997 requires that every ship be issued with a Safe Manning Certificate, commonly referred to as the Minimum Safe Manning Document (MSMD).
- 4. As required under the aforesaid regulations and statutory provisions, the Directorate General of Shipping has, from time to time, issued several executive orders, circulars, MS notices, and letters prescribing the minimum safe manning scales to be adhered to on Indian ships. Some of the executive orders and circulars issued in this regard are mentioned below:
 - a) Circular No. MSL-1(2)/95-II dated 27.12.2007.
 - b) MSL Branch Circular No. 3 of 2008 dated 02.09.2008.

- c) MSL Branch Circular No. 1 of 2010 dated 29.06.2010.
- d) Nautical Wing Circular NT/RADIO/01/2011 dated 05.12.2011.
- e) NT Wing Circular (NT/Safe Manning/Dredge) No. 01 of 2011 dated 13.05.2011.
- f) Circular No. MSL-1(2)/95-III dated 10.04.2012.
- g) MSL Circular No. 01 of 2013 dated 05.07.2013.
- h) RSV Notification 2013 annexed to DGS Order 18 of 2013.
- i) Coastal Vessel Rules Notification 2014 annexed to DGS Order 01 of 2014
- j) MS Notice Nautical 01 of 2022 dated 28.01.2022 and
- k) Any other DGS orders/Circulars/MS-Notices/Letters.
- 5. The Directorate made extensive consultations with the INSA and ICCSA for rationalizing the minimum manning scales prescribed through several circulars and prepared the comprehensive guidelines to address the needs of the Indian shipping industry. This DGS circular consolidates all the above listed orders and circulars issued in relation to the safe manning of Indian ships, including those listed above. These circulars and notifications collectively formed the regulatory framework governing safe manning requirements and, through this consolidated order, are now brought under a single unified directive to ensure greater clarity, regulatory consistency, ease of compliance, and effective implementation across the Indian maritime sector.
- 6. Annexures A, B, C, D, E1- E2, F1- F7, G1-G7 prescribing minimum manning scales are attached with this circular, consolidating the safe manning provisions based on the types of ships and their respective areas of operation.

- 7. Annexure A to F are applicable to all types of self-propelled vessels registered under the Merchant Shipping Act except for the passenger vessels. The safe manning scale for passenger ships, Ro-Ro and RoPax, special trade passenger vessels, RSV passenger vessels, and high-speed passenger craft has been prescribed in the Annexure G (1 to 7).
- 8. It may be noted that the manning scales prescribed in the annexures reflect the minimum levels of manning necessary for safety of navigation and ship operation. The ship owners/managers shall consider engaging additional personnel as may be required based on the maintenance requirements, frequent cargo operations, short voyages etc., in order to ensure rest periods of seafarers.
- 9. Therefore, the ship owners/managers shall submit the proposal for safe manning of ships considering the guidelines and framework for determination of safe manning as given in A.1047(27). Companies shall submit the self-assessment checklist regarding the proposed manning while submitting an online application to the MMDs. The MMDs shall review the proposal submitted by the company based on the minimum scales prescribed in the circular and any additional manning proposed by the company based on the operational requirements to meet the requirements of rest hours and approve the proposal. The MMDs shall not accept any proposal which contains manning less than the number of personnel prescribed in the circular. All ships are required to be manned in accordance with the specified manning scale

mentioned in the approved Minimum Safe Manning Document (MSMD) issued by the administration.

10. In the event of an exigency necessitating a temporary deviation from the prescribed manning, such as due to the injury, illness, or unavailability of a crew member an application for dispensation may be submitted to the Nautical wing of the DGS. Such applications must comply with the requirements outlined in DGS Circular 04 of 2005 dated 31st March 2005. In urgent cases, the designated officers of the Nautical wing may be contacted directly via telephone. The contact numbers and email addresses are available on the official website of the Directorate General of Shipping.
