ORDER

Whereas, M/s Fairmacs Catering Company Pvt. Ltd [hereinafter to be referred as "RPS agency"] was issued with Recruitment & Placement Service License bearing No. RPSL-MUM-162073 valid from 02.11.2021 to 02.11.2026 by the Director, Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016.

2. And whereas, it was observed that RPS agency had failed to undergo Annual Inspection for the years 2023, 2024 and 2025 within stipulated time-limit and therefore, is observed to be in violation of Rule 5(1)(z) and Rule 13(2) of M.S. (R&PS) Rules, 2016 to be read with Para 1.8 of DGS Crew Br. Circular No. 03 of 2016 dated 23.08.2016.

3. And whereas, a show cause notice under Rule 12(1) of M.S. (R&PS) Rules, 2016 was issued to RPS agency vide this office letter No. 35321-MMDMUM-14011(16)/1/2025/435/2025 dated 31.07.2025 for the observed violations mentioned vide Para 2 above.

4. And whereas, RPS agency submitted reply to show cause notice vide letter dated 07.10.2025 stating that RPS agency wish to surrender RPS license and requested for return of Bank Guarantee amounting to INR 15 Lacs submitted to this office.

5. Based upon the aforesaid and RPS agency' own request, the Director, Seamen's employment Office exercising the power vested upon them in accordance with Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 orders following:

5.1 Recruitment and Placement Service (RPS) License bearing No. RPSL-MUM-162073 in respect of M/s Fairmacs Catering Company Pvt. Ltd is hereby WITHDRAWN by the Director, Seamen's Employment Office, Mumbai in terms of Rule 12 of Merchant Shipping (Recruitment & Placement of Seafarer) Rules, 2016 with immediate effect.

5.2 M/s Fairmacs Catering Company Pvt. Ltd & its associated Directors continue to remain liable for the seafarers who have already been recruited by them and those who are presently serving onboard.

5.3 The submitted Bank Guarantee amounting to INR 15,00,000/- (INR Fifteen Lacs Only) of M/s Fairmacs Catering Company Pvt. Ltd withheld with this office and shall only be returned on submission of requisite documents to this office as per the checklist for the same.

6. If, M/s Fairmacs Catering Company Pvt. Ltd, feels aggrieved by the order passed herein, it may within a period of thirty (30) days of receipt of this order, prefer 1<sup>st</sup> appeal to the Principal Officer, Mercantile Marine Department, Mumbai, being the First Appellate Authority in the matter, in accordance with Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016. [It may be noted that Rule 18 mentioned under Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 is to be read as Rule 12 view typographical error in Gazette Notification No. G.S.R. 169 (E) dated 15.02.2016].
