### WITHDRAWAL ORDER

Whereas, M/s Red Ocean Shipping Mgmt. Pvt. Ltd. [hereinafter to be referred as "RPS agency"] was issued with Recruitment & Placement Service License bearing No. RPSL-MUM-386 valid from 30.08.2016 to 01.02.2021 by the Director, Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016.

2. And whereas, RPS agency vide e-mail dated 30.09.2025 intimated regarding closure of their company and surrender of RPS license No. RPSL-MUM-386 issued against their name. Checklist of documents for return of Bank Guarantee was intimated to RPS agency vide this office e-mail dt 06.10.2025.

3. Based upon the aforesaid and RPS agency' own request, the Director, Seamen's employment office exercising the power vested upon them in accordance with Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 orders following:

3.1 Recruitment and Placement Service (RPS) License bearing No. RPSL-MUM-386 in respect of M/s Red Ocean Shipping Mgmt. Pvt. Ltd. is hereby WITHDRAWN with immediate effect by the Director, Seamen's Employment Office, Mumbai in terms of Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 with immediate effect.

3.2 M/s Red Ocean Shipping Mgmt. Pvt. Ltd. & its associated Directors continue to remain liable for the seafarers who have already been recruited by them and those who are presently serving onboard.
