

WITHDRAWAL ORDER

Whereas, M/s Shri Mahavir Marine Services Pvt. Ltd. [hereinafter to be referred as "RPS agency"] was issued with Recruitment & Placement Service License bearing No. RPSL-MUM-254 valid from 31.03.2023 to 31.03.2028 by the Director, Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016.

2. And whereas, RPS agency vide e-mail dated 30.09.2025 intimated regarding closure of their company and surrender of RPS license No. RPSL-MUM-254 issued against their name. Checklist of documents for return of Bank Guarantee was intimated to RPS agency vide this office e-mail dt 06.10.2025.

3. Based upon the aforesaid and RPS agency' further own request, the Director, Seamen's employment office exercising the power vested upon them in accordance with Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 orders following:

3.1 Recruitment and Placement Service (RPS) License bearing No. RPSL-MUM-254 in respect of M/s Shri Mahavir Marine Services Pvt. Ltd. is hereby WITHDRAWN with immediate effect by the Director, Seamen's Employment Office, Mumbai in terms of Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 with immediate effect.

3.2 M/s Shri Mahavir Marine Services Pvt. Ltd. & its associated Directors continue to remain liable for the seafarers who have already been recruited by them and those who are presently serving onboard.
