ORDER

Whereas, M/s Amsway Marine Pvt Ltd [hereinafter to be referred as "RPS agency"] was issued Recruitment & Placement Service (RPS) License bearing No. RPSL-MUM-162293 valid from 18.12.2024 to 18.12.2029 by the Director, Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016.

2. And whereas, it is observed that RPS Agency has failed to comply with the following provisions for the following reasons:

2.1 Whereas, it is observed from Directorate's E-governance online records that RPS agency has been engaged in the recruitment of seafarers which exceeds the operational capacity of the vessel NOBEL, IMO No. 9105114 (11 seafarers) which is deemed in violation of Rule 5(1)(a) of Merchant Shipping (Recruitment & Placement of Seafarer) Rules, 2016 and terms of Merchant Shipping Notice No. 11 of 2024 dated 03.06.2024.

3. And whereas, a show cause notice under Rule 12(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 was issued vide this office letter of even number dated 05.05.2025 for afore-mentioned violations of said rules. Simultaneously, RPS agency' online privileges in DGS online system to further e-migrate and sign-on the seafarers were suspended w.e.f. 02.05.2025 in terms of provisions of Merchant Shipping Notice No. 11 of 2024 dated 03.06.2024.

3.1 And whereas, RPS agency' response to the show cause notice received vide letter dated 30.05.2025 was observed inadequate / not appropriate and therefore, a personal hearing under Rule 12(2) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 was scheduled with RPS agency on 21.07.2025 vide this

office letter of even number dated 04.07.2025. However, neither any representative of RPS agency reported for the hearing nor any intimation in this regard was received from RPS agency by this office.

3.2 And whereas, a 2nd notice of personal hearing under Rule 12(2) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 was issued vide letter of even number dt 09.10.2025 whereby hearing was scheduled on 04.11.2025. Mr. Ali Hasan, Director, M/s Amsway Marine Pvt. Ltd. reported for the hearing wherein he stated that he was not aware of the working of the RPS agency and was not able to provide any details pertaining to the RPS agency. The Director also made a written submission of the same to the said effect.

4. And whereas, during the course of proceedings this office continued to receive grievances from seafarers against RPS agency, a brief of which is appended below:

4.1 Shri Satveer Bhadana bearer of INDoS No. 24ZQ7622 registered grievance vide online DGS Portal Ref # GRS/SMO(M)/2025/5208 dt 09.05.2025 and CPGRAM portal bearing registration No. PMOPG/E/2025/0064940 dt 09.05.2025 stating that he was sent to Dubai on 16.04.2025 for placement onboard in lieu of service charge. However, he was offered placement onboard a different vessel from the one updated in online DGS Master Checker records which the seafarer refused to join and returned to India on 26.04.2025 at his own expense. Online Form-I record of seafarer has subsequently been deleted / cancelled by RPS agency. Matter was taken up with RPS agency vide this office letter of even number dated 13.05.2025. However, no adequate / appropriate response was received from RPS agency in the matter.

4.2 Shri Omprakash Khatana bearer of INDoS No. 24ZQ7611 registered grievance vide online DGS Portal Ref # GRS/SMO(M)/2025/5209 dt 09.05.2025 and CPGRAM portal bearing registration No. PMOPG/E/2025/0065154 dt 09.05.2025 stating that he was sent to Dubai on 16.04.2025 for placement onboard in lieu of service charge. However, he was offered placement onboard a different vessel from the one updated in online DGS Master Checker records which the seafarer refused to join and returned to India on 26.04.2025 at his own expense. Online Form-I record of seafarer has subsequently been deleted / cancelled by RPS agency. Matter was taken up with RPS agency vide this office letter of even number dated 13.05.2025. However, no adequate / appropriate response was received from RPS agency in the matter.

4.3 Shri Tarachand Poswal bearer of INDoS No. 24ZQ7620 registered grievance vide online DGS Portal Ref # GRS/SMO(M)/2025/5210 dt 09.05.2025 and CPGRAM portal bearing registration No. PMOPG/E/2025/0065172 dated 09.05.2025 stating that he was sent to Dubai on 16.04.2025 for placement onboard in lieu of service charge. However, he was offered placement onboard a different vessel from the one updated in online DGS Master Checker records which the seafarer refused to join and returned to India on 26.04.2025 at his own expense. Online Form-I record of seafarer has subsequently been deleted / cancelled by RPS agency. Matter was taken up with RPS

agency vide this office letter of even number dated 22.05.2025. However, no adequate / appropriate response was received from RPS agency in the matter.

4.4 Shri Rajendra Bhadana bearer of INDoS No. 24ZQ9123 registered grievance vide online DGS Portal Ref # GRS/SMO(M)/2025/5211 dt 09.05.2025 and CPGRAM portal bearing registration No. PMOPG/E/2025/0065160 dt 09.05.2025 stating that he was sent to Dubai on 16.04.2025 for placement onboard in lieu of service charge. However, he was offered placement onboard a different vessel from the one updated in online DGS Master Checker records which the seafarer refused to join and returned to India on 26.04.2025 at his own expense. Online Form-I record of seafarer has subsequently been deleted / cancelled by RPS agency. Matter was taken up with RPS agency vide this office letter of even number dated 13.05.2025. However, no adequate / appropriate response was received from RPS agency in the matter.

4.5 Shri Guruvindersingh Manjeetsingh Dhillon bearer of INDoS No. 24ZN7275 registered grievance vide online CPGRAM Portal bearing registration No. PMOPG/E/2025/0132564 dt 04.09.2025 stating that he was sent to Iran for placement onboard in lieu of service charge. Whereas, the Form-I is updated by some other RPS agency and whereas, the seafarer has alleged to have paid service charge to Mr. Sajid claiming to be representing M/s Amsway Marine Pvt. Ltd. Matter was taken up with RPS agency vide this office letter of even number dated 09.09.2025. However, no adequate / appropriate response was received from RPS agency in the matter.

4.6 Shri Lavprit Singh bearer of INDoS No. 24ZN9729 registered grievance vide online CPGRAM Portal bearing registration No. PMOPG/E/2025/0132683 dt 04.09.2025 stating that he was sent to Iran for placement onboard in lieu of service charge. Whereas, the Form-I is updated by some other RPS agency and whereas, the seafarer has alleged to have paid service charge to Mr. Sajid claiming to be representing M/s Amsway Marine Pvt. Ltd. Matter was taken up with RPS agency vide this office letter of even number dated 09.09.2025. However, no adequate / appropriate response was received from RPS agency in the matter.

5. Therefore, it is concluded herein that RPS agency has no valid explanation to tender and it is evident from all the above that said RPS agency is guilty of conducting its affairs in violations of Rule 5 in toto of Merchant Shipping (Recruitment & Placement of Seafarer) Rules, 2016 promulgated vide Gazette Notification GSR No. 169 (E) dated 15.02.2016 and Merchant Shipping (Maritime Labour) Rules, 2016.

6. Based upon detailed proceedings conducted in the matter and in view of all the above, the Director Seamen's employment Office exercising the power vested in accordance with Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 orders following:

6.1 Recruitment and Placement Service (RPS) License bearing No. RPSL-MUM-162293 in respect of M/s Amsway Marine Pvt Ltd is hereby **WITHDRAWN** with immediate effect by the Director, Seamen's Employment Office, Mumbai in terms of Rule 12 of Merchant Shipping (Recruitment & Placement of Seafarer) Rules, 2016.

6.2 M/s Amsway Marine Pvt Ltd & its associated Directors continue to remain liable for the seafarers who have already been recruited by them and those who are presently serving onboard.

6.3 All concern Directors of RPS agency, M/s Amsway Marine Pvt Ltd (Founders / Past / present) are hereby debarred from carrying out any maritime related activities associated with The Directorate General of Shipping for a period of five (05) years and further recommendation shall be forwarded to Ministry of Corporate Affairs (MCA) for blacklisting of DIN numbers of RPS agency Directors to restrain them to carry out any business activities in India for a period of five (05) years in terms of Merchant Shipping Notice No. 11 of 2024 dated 03.06.2024.

6.4 The submitted Bank Guarantee amounting to INR 10,00,000/- (INR Ten Lakhs Only) of M/s Amsway Marine Pvt Ltd is to be hereby invoked and shall be deposited into Government Account in terms of provisions of Rule 15 of MS (R&PS) Rules. 2016 inter-alia under sub-rule 5(c) of Rule 15 of MS (R&PS) Rules. 2016.

7. If, M/s Amsway Marine Pvt Ltd, feels aggrieved by the order passed herein, may within a period of thirty (30) days of receipt of this order, prefer 1st appeal to the Principal Officer, Mercantile Marine Department, Mumbai, being the First Appellate Authority in the matter, in accordance with Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016. [It may be noted that Rule 18 mentioned under Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 is to be read as Rule 12 view typographical error in Gazette Notification No. G.S.R. 169 (E) dated 15.02.2016].
