**WITHDRAWAL ORDER**

Whereas, M/s Able Angel Ship Mgmt. Pvt. Ltd. [hereinafter to be referred as "RPS agency"] was issued with Recruitment & Placement Service License bearing No. RPSL-MUM-361 valid from 13/11/2020 to 13/11/2025 by the Director, Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016.

2. And whereas, RPS agency vide letter dated 24.11.2025 intimated regarding closure of their company and surrender of RPS license No. RPSL-MUM-361 issued against their name.

3. Based upon the aforesaid and RPS agency' own request, the Director, Seamen's employment office exercising the power vested upon them in accordance with Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 orders following:

3.1 Recruitment and Placement Service (RPS) License bearing No. RPSL-MUM-361 in respect of M/s Able Angel Ship Mgmt. Pvt. Ltd. is hereby WITHDRAWN by the Director, Seamen's Employment Office, Mumbai in terms of Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 with immediate effect.

3.2 M/s Able Angel Ship Mgmt. Pvt. Ltd. & its associated Directors continue to remain liable for the seafarers who have already been recruited by them and those who are presently serving onboard.

3.3 The submitted bank guarantee amounting to INR 10,00,000/- (INR Ten Lakhs only) of M/s Able Angel Ship Mgmt. Pvt. Ltd. withheld with this office and shall only be returned on submission of requisite documents to this office as per the checklist for the same.

4. If, M/s Able Angel Ship Mgmt. Pvt. Ltd, feels aggrieved by the order passed herein, it may within a period of thirty (30) days of receipt of this order, prefer 1<sup>st</sup> appeal to the Principal Officer, Mercantile Marine Department, Mumbai, being the First Appellate Authority in the matter, in accordance with Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016. [It may be noted that Rule 18 mentioned under Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 is to be read as Rule 12 view typographical error in Gazette Notification No. G.S.R. 169 (E) dated 15.02.2016].
