## Maritime Training Trust (Tonnage Tax Cell) Circular No. 01 of 2012

Sub - Grant of license to foreign flag ships under section 406 or 407 of the Merchant Shipping Act, 1958, laying down the norms for engaging Indian crew on board these ships in the Indian coastal waters - reg.

Reference is invited to the Directorate General of Shipping (DGS), Govt. of India Circular No. 1B of 2011 (F.No. MSL-24(1)/2008) dated 12.01.2011 laying down norms for engaging Indian crew on foreign flag vessels chartered under section 406 & 407 of the Merchant Shipping Act, 1958, as amended. The said guidelines were modified vide the Shipping Development Branch Circular no. 2 of 2011 (F.No. SD-9/Chart(82)/97-V) dated 25.05.2011 of the DGS, as under;

- The companies / shipowners / charterers should deploy the prescribed no. of 1.1. Indian crew / officers within 90 days from the date of grant of such license, interalia.
- In the case of non-deployment of the required no. of Indian crew / officers, the 1.2. above entities should provide training slots for the Indian crew / officers on the same scale as prescribed in the tonnage tax scheme for the entire period of requirement of the license in respect of the deficient no. of man-days required under the said Circular 1B of 2011 including the said initial period of 90 days.
- An undertaking, to this effect, that the training slots will be provided during the 1.3. calendar year should be given.

- 1.4. Such an applicant for the said license is permitted to offer training on the ships of any other Indian company from the surplus training slots available under the tonnage tax scheme.
- 2. The said training commitment, in lieu of not employing the stipulated number of Indian officers / crew on the foreign flag vessels chartered under section 406/407 of the Merchant Shipping Act, 1958, has to be fulfilled by the 31st December of each calendar year, by the companies who have been issued such charter licenses. The charterers who have opted to buy the training mandays from the tonnage tax companies which have surplus training slots shall submit an undertaking from such companies stating that they have allotted the specified no. of training mandays from the surplus training carried out by them on board their qualifying vessels. The Maritime Training Trust (MTT), which is the agency nominated by the Competent Authority, in this regard shall verify the said training mandays offered to the charterers in this regard.
- 3. To enable the said verification by the MTT, of the same, returns in the following Forms have to be submitted by the said companies which have sold the said training slots;
- 3.1. <u>Form-1</u>: This will indicate the vessel-wise details of the training mandays purchased by such companies / ship-owners / charterers from the tonnage tax companies for fulfilling their said training commitment during the given calendar year. The format of the said Form 1 is enclosed in the Annexure I (1 page).
- 3.2. <u>Form-2</u>: This will indicate the trainee-wise details of the total training mandays actually imparted by a tonnage tax company during the relevant period of the said license issued for chartering foreign flag vessel(s). The format of the said Form 2 is enclosed in the Annexure II (1 page).
- 4. The said prescribed Forms 1 and 2 should be submitted to the CEO, MTT at his aforesaid address, on or before the 31st of January of every calendar year. For the calendar year, 2011, the said returns shall be submitted by latest 31.03.2012.

5. This issues with the approval of the Director General of Shipping and ex – Officio Additional Secretary to the Government of India.
