

MMD MUMBAI." This fee is applicable to every candidate irrespective of the number of subjects intending to appear.
3. Three passport size photograph (35 mm X 35 mm Size);
4. Self certified copy of the Passport, CDC, MEO-Class I, Extra First Class (Part A /Part B) course completion certificate;
5. Documents as mentioned at the Part 2, 3 & 4 are to be attached with Application Form as mentioned in the Para 1 and shall be submitted in an A4 size envelope before commencement of the first examination. For candidates (Repeaters as well as fresher's)
6. Candidates desirous to appear in the aforesaid examination are requested to inform the Directorate mentioning name of the subjects (in which they intend to appear) through e-mail (to Dutta-dgs@ nic.in) latest by 20<sup>th</sup> August 2018.


