## CORRIGENDUM

Reference to this office Tender Notice No. 02 of 2019 dated 17 Oct 2019 (Tender ID 2019\_MMD\_511601) and corrigendum dated 01/11/2019 in respect of Tender No. 02 of 2019 regarding personalization of CDC/ COC booklets and Renewal Stickers for CDC & COC booklets, in continuation to that following amendment is hereby notified in aforesaid tender:

- New amended format of Financial Bid for submission by bidders is placed as 1. Annexure B(i) (copy enclosed).
- Para 2(i) of Annexure D under details of work to be performed by the contractor to be read as:

"Annual volume of applications for personalization of booklets is expected to be 1,00,000. However, the inflow of applications may not be uniform. The bidders will set up facility to personalize booklets as mentioned against each locations:

- a) 400 CDC booklets per day in Government Shipping Office, Mumbai
- b) 200 CDC booklets per day in Government Shipping Office, Kolkata
- c) 200 CDC booklets per day in Government Shipping Office, Chennai
- d) 100 COC booklets per day in DG Shipping, Mumbai"
- Para h of Annexure G under statutory and contractual obligations to be complied with by the contractor to be read as:

"The successful bidder shall have to deposit an amount equivalent to 10% of the total Contract Value per annum as 'Security Deposit' during the contract. On submission of this Security Deposit, the EMD of the successful Bidder will be returned."



4. Para 19 of Technical Bid i.e Annexure A to be read as:

"Details of Hardware, software, and uninterrupted power supply unit proposed to be deployed at Government Shipping Office located in Mumbai, Kolkata, Chennai and Directorate General of Shipping, Mumbai for execution of the job: (Please specify make, mode and capacity of each equipment)".

5. Para 4 of Annexure C under Job Specifications to be read as:

"The printer shall be provided by the Contractor, having minimum of 1000 DPI resolution, should be capable of printing colour photographs and black character text printing directly on the pre-printed CDC/COC Booklet / Renewal Stickers."

6. Para 9(c) of Section C under Bidding Process to be read as:

"As part of technical evaluation, the bidders would be asked to organize a technical demonstration of the hardware and technology they would use for executing the job. The demonstration shall be held at Government Shipping Office, Mumbai within 15 days after the opening of the technical bids. On the day of demonstration, the bidders will bring, at their own cost, the complete setup including Printer, Laminator, PC, any other equipment and software necessary for this purpose. DG Shipping shall provide soft copy of data in standard format for printing of CDC booklet and blank envelope. The Bidder is expected to use this data for generating personalized booklets as mentioned under the head "DELIVERABLES" and demonstrate the printing, lamination and Quality Assurance for reading the printed booklet on the ICAO compliant travel document readers and on blank envelopes."
