

#### Scope and Terms & Conditions:-

Due to current Pandemic situation, Mercantile Marine Department, Kolkata under the Ministry of Shipping, Govt. of India requires the following services:-

- 1. Sanitization and disinfectation service on weekly basis (once in a week) at its premises located at Marine House, Napier Road, Hastings, Kolkata.
- 2. Quotations are invited from authorized pest control/disinfectation service providers experienced in carrying out such services in large office buildings in Kolkata.

- 3. The Marine house premises cover approximately an area of 38000 sq. Ft. built up area including staircases, lifts, rooms, store rooms, toilet, corridors etc.
- 4. The rate quoted should be the consolidated rate for the entire building including all furniture and fixtures for one sanitization job only.
- 5. The firm/agency may satisfy the following conditions and attach self-attested copy of the same with bids:
  - i. Firm shall have Pest Control License.
  - ii. The firm shall have valid PAN Number.
  - iii. The firm shall have valid GST certificate
  - The Firm should have evidence of similar work carried out in the office premises.
- 6. Payment will be made on the number of sanitization job carried out per month which will be at the discretion and instruction of PO, MMD, Kolkata. The rates fixed for sanitization will be fixed as per the convenience of PO, MMD, Kolkata and will be intimated to the service provider 2 days in advance.
- 7. Disinfectation medium used has to be Alcohol and Hydrogen Para Oxide or equivalent. The chemical used have to be environment friendly and safe for Human beings. The service provider will be penalized and appropriate action will be taken if any adverse impacts are notices due to the disinfectation/sanitization process.
- 8. MMD, Kolkata will not provide any facilities or labour for the same.
- 9. This contract will be a short term contract and validity will be subject to the existence of the pandemic situation.
- 10. PO, MMD, Kolkata has the right to terminate the contract of the Successful bidder at any time without assigning any reason whatsoever.
- 11. MMD, Kolkata reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the MMD, Kolkata will be final in this regard.
