NOTICE TO ENGINEERING CANDIDATES

Subject: Conduct of Certificates of Competency Examinations of all Engineering grades

- 1. Further to the Notice to Engineering candidates issued on 22.06.2020, for conduct of August 2020 oral examinations, the Directorate has decided to commence the booking for *oral examinations* of all MEO/ETO and NCV grades in the month of September 2020.
- 2. The written examination of the disrupted March 2020 MEO CL-II Naval architecture paper shall be completed as soon as the normalcy in public service and restrictions imposed by various local governments due to Covid-19 is removed and thereafter the conduct of regular written exams for all grades will be scheduled by the Directorate.
- 3. Accordingly, the booking for oral examinations will commence from 1st September 2020 and will close on 10th September 2020. These candidates are to book for their oral examinations as stated below:
 - (i) MEO Class IV through DGS e-pariksha module
 - (ii) ETO, MEO Class II and MEO Class I through DGS e-governance module.
 - (iii) NCV all grades to book the examinations by email to the respective MMD Examiner of Engineers, mentioning the functions which they intend to appear and also paying the applicable fees through Bharat Kosh and sending the receipt of the fees by mentioning their Name ,INDOS number, Grade of Examination and functions applied for. Email for NCV exams to be clearly marked as "NCV grade of Exam- Name of Candidate-INDOS number" in the subject of the email.

4. All those candidates who are sailing on ships or intend to join shortly are advised not to apply

for the examination as the oral examination can only be taken when the candidate is signed off

from ship and is ashore in India. Concealment of the facts will be construed as misconduct and

may attract punitive actions as per the rules.

5. The candidates appearing for online oral examination from onboard ship shall not be allowed

and shall be marked as "FAILED (Absent)" and no refund shall be applicable who have booked

the examination but found appearing from ship on the scheduled day of the examination.

6. Candidates should note that even if the conduct of oral is online it has to be planned and no

such requests to conduct their orals at the earliest or at a later date shall be entertained at the

DGS or MMDs. Candidate can only use laptop with camera (use of mobile phone not allowed)

from an empty room and meet and follow all the requirements to appear the online oral

examinations (for requirements refer Standard Operating Procedure on Usage of online

platform for conduct of candidate's oral examination for Certificate of Competency (CoC)

during the period of COVID-19, enclosed as Annexure II to earlier issued Notice to Engineering

Candidates on 11.06.2020).

7. It has been observed that the candidates during online orals are facing internet issues and

issues with computers etc. All candidates are advised to check their laptops / desktops and the

internet at home to ensure that they don't get last minute surprises. Also appearing for oral

examinations from mobile phone is not allowed. Please ensure that you have the proper

equipments before you apply for the examination.
