## "Quotation for Installation of CCTV system at MMD Haldia"

### The scope of work:-

To carry out the installation of new CCTV system with both indoor and outdoor units as specified, which shall include provisioning for monitoring from 2 stations within the building and remote monitoring on mobile/tablet/laptop through internet. The quality of work should be to the satisfaction of this department.

## **Terms and Condition:**

- 1. The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation.
  - i. Firm shall be registered with the Government of West Bengal/Central Government with office in Haldia/ East Midnapore district.
  - ii. The firm shall have valid PAN Number.
  - iii. The firm shall have valid GST certificate
  - iv. Proof of their service rendered in other offices.
  - v. Bidder should have experience of having successfully completed similar works (Please submit copy of Purchase Order and completion Certificate from the Client.)
  - vi. The Bidder firm should not be defaulted/black listed/banned by any Government/PSU/Department of India (An undertaking from the bidder firm letter head stating that the firm has not been blacklisted by any Central Government Department/Ministry/PSU/Bank, or State Government etc. must be attached with the bid documents.)
  - vii. Tender Acceptance letter (To be given on company letter head)
  - viii. Names, address, contact number of the proprietor/partners/ shareholders of the bidding concern to be provided.

- 2. The Installation will be comprehensive with minimum 1 year warranty and no extra payment will be made for spare parts and special services utilized, if any during the Warranty Period.
- 3. One year warranty to include any Maintenance which is system related, software related activities, uninstallation and integrity maintenance to make the system/equipment/network functional.

# 4. Performance Security Deposit:-

The successful bidder will have to submit an interest free security deposit of an amount equivalent to 5% of contracted work in the form of Bank Guarantee/ Fixed deposit valid for a period of fourteen months from the installation date to this department and same will be returned after completion of warranty period.

- 6. No advance payment will be made.
- 7. The security money shall liable to be forfeited or appropriated in the event of unsatisfactorily performance of the contractor or in the event of breach of the agreement by the contractor.
- 8. Any work, preventive as well as breakdown, shall be attended to within the same day over a telephonic complaint being logged by the officer's and staff members.
- 9. The components/parts used by the company should be original parts from the maker of the equipment.


