NOTICE TO CANDIADATES INTENDING TO APPEAR ENGINEERING GRADE COC EXAMINATIONS IN JANUARY 2021 DURING THE PERIOD OF COVID-19

Subject: MEO/ETO/NCV Grade written examinations schedule for January 2021 - reg.

As per guidelines issued by the Govt. of India for unlock period, the MEO/ETO grade written examinations resumed from month of October 2020 adhering to the SOP dated 07.09.2020 issued by the Directorate.

- 2. Conduct of MEO Class IV and NCV grade written examinations in the centres of APTECH and IMEI (Mumbai) respectively (the agencies entrusted to conduct examinations at their centres) is still not being made possible due to non-availability of their services. Hence, the MEO Class IV written examinations will continue to take place in exam centre of MMD (Mumbai/Chennai/Kolkata/Kochi/Noida) and the NCV examination in MMD, Mumbai, for the month of January 2021.
- 3. Further, the MEO Class IV grade written examination shall be conducted at MMD exam centres on "off line" mode using paper and pen (No computer) but there is no change in the examination question pattern. Similarly, the NCV Class III SEO (part A & B) grade written examination shall be conducted at MMD, Mumbai exam centre on "off line" mode using paper and pen (No Tablets) and there is no change in the examination question pattern.
- 4. The maximum number of candidates that can be accommodated in each Examination centres is given below.

- 5. The seat booking for examination in January 2021 shall remain open as follows
 - (i) MEO Class-I, Class II both Part A & B and ETO through DGS E-Gov from 04.01.2021 till 08.01.2021 (mid night)
 - (ii) MEO Class IV both Part A &B through DGS E-Pariksha from 04.01.2021 till 08.01.2021 (mid night)
 - (iii) NCV Class III (SEO) both Part A & B through IMEI (Mumbai) 04.01.2021 till 08.01.2021 as per **Annex-I.**
- 6. All candidates are required to report at exam centre as per schedule (Annex-II).

Procedure for application to appear NCV Grade written examination at MMD Mumbai Examination Centre.

- 1. Eligible candidates who intend to appear NCV grade written examination as per schedule (*Annex-II*) to confirm their willingness to IMEI (Mumbai) through E-Mail latest by 04.01.202.
- 2. Candidates need to pay examination fees through Bharatkosh to MMD Mumbai and confirm seat booking through e-mail to IMEI (Mumbai) attaching the payment receipt.
- 3. IMEI to issue Admit card to such candidates
- 4. IMEI shall send list of candidates appearing for written examination in January 2021 (grade wise) to MMD, Mumbai.
- 5. Candidates are required to carry issued Admit card at the time of written examination at MMD, Mumbai (Examination hall)
