The job will involve regular entry into the Port area and service provider has to have the required authorizations from port authorities and cars and driver have to have the required valid port permits to enter and operate within the port.

- 7. The contract will be on no work no pay basis and the Surveyor in charge, MMD Haldia has the right to terminate the contract at any time without assigning any reason whatsoever.
