Subject: Intimation regarding booking for 2MFG, 1<sup>st</sup> Mate FG Ph- I & Ph-II, ASM(FG), and Fishing Grade (at Chennai only) written examinations and allgrades of oral examinations for March 2022 - reg

- 1. Booking window will be opened from 18.02.2022 to 24.02.2022 for fresh and repeater candidates of <u>2MFG</u>, 1<sup>st</sup> <u>Mate Ph- I (FG) & Ph- II(FG)</u>, <u>ASM(FG)</u>, <u>and Fishing Grades (at Chennai only, subject to bookings made) written examination</u>, tentatively scheduled to commence from 02.03.2022 [Note: The examination schedule has been displayed on DGS website. <u>The date may change depending on the circumstances</u>. Candidates may, therefore, continue to monitor DGS website for any change in date of examination.
- 2. Candidates may book for oral examination as per standard procedure.
- 3. Oral examination of nautical discipline will be accepted for those candidates who have passed written examination, as well as completed the relevant modular courses and eligible for the oral examination.
- 4. Candidates who are serving on a ship (Articles of a ship) are not eligible for applying for online examination.
- 5. Candidates who are unable to appear in online oral examination, may opt for attending the oral examination at MMDs. In such cases the candidates are required to specify by an email to the Exam Centre of the concerned MMD immediately upon booking with booking reference details, whether online or physical examination method is being selected. Even in such situation the oral examination at the MMD will normally be conducted through an online platform at the MMD.
- 6. Candidates choosing remote online platform need to comply with the requirements of Annex I of the notice dated 10.05.2021 regarding "Instructions to candidate for attending oral examination of nautical discipline using online video-conferencing platform.

- 7. Candidates who are not eligible for appearing in oral examination and those who cannot comply with Annex-I requirement (if remote online option is chosen) as stated in par 6 of this notice, may not book their seat as their fees would be forfeited.
- 8. Fresh applicants may complete the online assessment process at the respective MMDs as per usual practice. Candidates may forward the required documents for assessment of eligibility to the MMD through the institute by speed post or courier at the earliest. Candidate need not to visit MMD for the purpose of assessment. Once assessment is approved, fresh candidates can book seats for Examination.
- 9. The MMDs will display the dates of conduct of the signal visual examination. Candidates may therefore contact the respective MMD for details regarding the conduct of signal visual examinations.
- 10. This is issued with the approval of the Chief Examiner of Master and Mates and the Nautical Advisor to the Government of India (i/c).
