3. The documents received have been scrutinized based on EoI Section- 11 (Eligibility Criteria) and Section- 12.3 (Submission by the bidder)
4. Based upon the submissions done by the companies, Consultant Evaluation Committee (CEC) has found that the following companies are meeting the EoI eligibility criteria as stated in Section 11 of the EoI:

Company of Master Mariners of India: Based upon the documents submitted, the company does not have the required experience in providing consultancy services towards establishing of e-platforms or knowledge clusters, etc. for online collaboration of researchers and stakeholders in the maritime domain.
- b. GMCG Consultants Pvt. Ltd.: based upon the documents submitted the company does not have any experience in providing consultancy services towards establishment of e-platforms, knowledge clusters, etc. for online collaboration of researchers and maritime stakeholders.
