NOTICE- TENDER CANCELLATION

The Directorate General of Shipping (DGS) published RFP Tender Notice No.11-20011-/1/2020-COMP in the CPP portal on 21.12.2021 & its subsequent corrigenda for Selection of System integrator for e-Governance Solution and IT Transformation of Directorate General of Shipping.

2. The Directorate issued Letter of Intent (LoI) for awarding of the contract to L-1 i.e. TCS and requested to furnish the Letter of Acceptance (LoA) within two weeks from the issuance of the LoI.

3. The TCS had not submitted LoA and had requested changes in RFP conditions especially related to clause 15.3 volume 3 page 26 of RFP on Limitation of Liability.

4. Further, following clause of the RFP documents may also be referred:

(i) RFP Clause 7.7 (I) of Volume-I: Failure to agree with the Terms and Conditions of the RFP:-
Failure of the successful bidder to agree with the Draft Legal Agreement and Terms & Conditions of the RFP shall constitute sufficient grounds for the annulment of the award, in which event DGS may award the contract to the next best evaluated bidder or call for new proposals from the interested bidders.

(ii) RFP Clause 4.1 (I) of Volume-I: Right to Terminate the Process of the RFP:-
DGS may terminate the RFP process at any time and without assigning any reason. DGS makes no commitments, express or implied, that this process will result in a business transaction with anyone.

5. In view of above, the RFP Tender Notice No.11-20011-/1/2020-COMP dated 21.12.2021 is hereby cancelled.

6. This issues with the approval of Director General of Shipping and in the rank of Secretary to the Govt. of India.
