1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. 2. Generic

3. **Payment**



2. Responsibilities:

The engagement of an Electrician is crucial for maintaining a safe and operational working environment at DGS. This procurement will:

- **Ensure Uninterrupted Electrical Maintenance:** The Electrician will be responsible for inspecting, repairing, and maintaining electrical installations to prevent outages and failures.
- **Enhance Safety Compliance:** Proper maintenance helps in preventing electrical hazards, ensuring adherence to safety norms and compliance with regulations.
- **Prevent Operational Disruptions:** A well-maintained electrical infrastructure is necessary for the seamless functioning of administrative and technical operations.
- **Ensure Continuity of Service:** The replacement of the current electrician with a new one will allow for a smooth transition, avoiding any gaps in service.
- **Facilitate Timely Repairs and Upgrades:** The Electrician will also assist in electrical infrastructure upgrades and the procurement of required consumables such as wiring, fuses, circuit breakers, and switches, ensuring that the organization's electrical systems remain functional and efficient.


